Hirsi, a junior at Barnard in New York City, announced her suspension on social media, stating she was one of three students penalized for supporting Palestinians.

"I've received notice that I am one of three students

suspended for standing in solidarity with Palestinians facing genocide," Hirsi wrote on her social media platform. She highlighted her involvement with Columbia University Apartheid Divest and her clean disciplinary record during her three years at Barnard.

The suspension comes after Omar's constant calls for a ceasefire. Earlier this

Even parents who work from home fear the change could impact their ability to leave the house for any reason, such as buying groceries, going to doctors appointments or running other errands.

Thousands of families could face these crossroads if the rule change became official. More than 7,000 individuals received private duty nursing in 2022, according to the state, though that may include some adults who receive the services through other specialized health care programs.

When asked what spurred HHSC to propose the rule change, spokesperson Jennifer Ruffcorn said in a statement that they were "clarifying the existing private duty nursing rules and

policy."

According to the agency, this is how they've always interpreted the policy. Because of this, HHSC "is not setting new or different expectations about how this policy is monitored or reported," Ruffcorn said. But, advocates say, the formalized proposal could create confusion for nursing provider companies and affect families' eligibility for their services.

Nurse monitoring

JaReen Williams' 16-year-old daughter can't use the bathroom on her own. She has a neurogenic bladder, colonic dysmotility and fecal impaction, so a nurse spends hours at their house helping with her catheter and bowel program. Sometimes, the entire process can take four or five hours.

Williams works from home and has her own disability. But under the rule change, she would have to bring her daughter and her daughter's nurse to doctor's appointments with her.

appointments with her.

"If Mom has to go somewhere, and I'm in the middle of doing all this, I personally wouldn't be able to leave my patient and then follow Mom around," Ify Ozoh, the private duty nurse for Williams' daughter, said. "I can't do that. My patient comes first."

Some advocates have argued the rule change wouldn't just harm patients and their families — it also

denigrates nurses by equating the medical care they provide with child care, or suggesting another adult needs to be with the nurse at all times.

"I really don't want anyone hovering over me trying to watch what I'm doing. I know what I'm doing," Ozoh said. "I went to school for it. It will make me feel like, 'OK, don't you trust me?""

Jessie Sage Cheng, a registered nurse and consultant, has a daughter with multiple disabilities, including cerebral palsy. But she can't care for her own daughter because of her work, and she needs someone else to monitor her daughter's medical needs.

"One of the pillars of nursing is autonomy," Sage Cheng said. "It is being able to make autonomous decisions that are in the best interest of the patient. If you make somebody else responsible for what the nurse is doing, you've just stripped them of their autonomy."

Sage Cheng said it isn't fair to call nursing care "child care" just because a parent is away.

Paul's Concern for the Spiritual Welfare of the Thessalonian Believers

I Thessalonians 3:1-13

Part I

In many ways, the church at Thessalonica was indeed an exemplary This church of Macedonia was founded by the Apostle Paul on his Second Missionary Campaign (Acts 17:1-14). Paul had many pleasant memories of the brief time that he spent with this infant church. In this brief but awesome instructional letter, Paul encourages the Thessalonian believers to continue to excel in their faith, to increase their love for one another, and to give thanks always for all things in view of the Lord's imminent return.

As a spiritual parent, Paul was concerned that the infant church of believers would remain steadfast in their faith in view of the Imminent return of Christ. As we observe the text, it may be outlined as follows: I. The Revelation of the Believers' Troubled Condition — I Thessalonians 3:1-5; II. The Report That Brought Paul's Comfort — I Thessalonians 3:6-13.

I. The Revelation of the

Believers' Troubled Condition I Thessalonians 3:1-5

Because of Paul's continued conflicts with the Jews, he only ministered in Thessalonica for less than a month ("three Sabbaths" Acts 17:2). And because of his tender and affectionate concern about the progress of Thessalonian believers, Paul dispatched Timothy. Not able to return to Thessalonica due to opposition, Paul was unable to endure not knowing about the spiritual welfare of the young believers in Thessalonica (v.1). Timothy, described as a "brother and a minister of God and fellow worker in the gospel," was sent forth with the mission to "establish" the believers and "comfort" them with regard to their faith.

The word establish means "to strengthen or make firm," and the word comfort means "to encourage or exhort" (v. 2). Paul's concern for the believers in Thessalonica was related to the persecution and suf-

fering they were experiencing. It was crucial that they be established in their faith so that they were not "moved by these afflictions" (I Thessalonians 3:3). "Moved" may simply mean "disturbed or disheartened." Paul was concerned that the afflictions would cause those who are not firmly grounded in the faith to be discouraged and



become fainthearted.

After making a general statement that is true of all Christians - we are all "appointed" or destined for suffering of some kind (v.

3), Paul reminded the Thessalonian believers when he was with them to expect persecution (v. 4). Paul's grave concern was that these believers' faith would remain steadfast in the midst of the temptations of Satan (v. 5). Having discussed "The Revelation of the Believers' Troubled Condition" Thessalonians 3:1-5, let us observe "The Report That Brought Paul's Comfort" -I Thessalonians 3:6-13.

month, Omar and 55 other Democratic representatives sent a letter to President Biden and Secretary Blinken, urging them to halt arms assistance to Israel. An Israeli airstrike that killed seven World Central Kitchen humanitarian aid workers, including one American, served as the inspiration for the letter.

The representatives expressed deep concern over Israel's ongoing blockade of humanitarian aid to Gaza, which has exacerbated the region's descent into famine. They called for a comprehensive investigation into the airstrike and suggested withholding arms transfers to Israel until those respon-

sible are held accountable. The letter also highlighted the dire humanitarian situation in Gaza, where over 32,000 people have been killed since the conflict began, nearly half of whom are children. Omar and others noted that Israel's restrictions on aid flow have further intensified the crisis, with hundreds of aid trucks stranded at the Rafah border crossing due to Israeli constraints.


World Central Kitchen,

which has provided over 43 million meals to Palestinians in Gaza, has been forced to suspend its operations following the attacks on aid workers. They said the absence of this critical support will exacerbate the hunger crisis in the region.

The representatives concluded by urging the Biden Administration to reconsider its decision to approve new arms transfers to Israel, stressing the need for compliance with U.S. and international law.

"We again strongly urge you to withhold any offensive weapons transfers until the investigation into the airstrike is concluded. If it is found that this strike violated U.S. or international law, those responsible will be held accountable," Omar and others wrote. "And we again urge you to ensure that any future military assistance to Israel, including already authorized transfers, is subject to conditions to ensure it is used in compliance with U.S. and international law."

Omar has been advocating for a ceasefire since October 2023 and continues to voice her concerns over the humanitarian situation in Gaza.

STIs on the Rise: Protect Yourself!

Sexually transmitted infections (STIs) like syphilis have been rapidly increasing in Dallas County since 2015, according to the 2022 Dallas County Community Health Needs Assessment (CHNA).

More than 3,000 cases of syphilis were reported in 2020, and more than 688 people were diagnosed with HIV in Dallas County the same year. Statewide, 685 cases of congenital (newborn) syphilis were reported in 2021, according to the Texas Department of State Health Services, the highest one-year total to date.

"STIs are increasing, and most people who have STIs do not have symptoms. The only way to know you have an STI is to be tested regularly," said Helen King, MD, infectious disease specialist at Parkland Health and assistant professor in the Division of Infectious Diseases and Geographic Medicine at The University of Texas Southwestern Medical Center.

April is STI Awareness Month, but Parkland Health experts want to remind you that we offer testing, treatment, and STI education year-round throughout our health system, including at our 16 Community Oriented Primary Care (COPC) health centers and through our Access to Care & Coverage Program, which brings Parkland to a neighborhood near you.

"Parkland is committed to reducing STIs in our community by empowering our community members to take control of their sexual wellness," said Dr. King. "Getting tested, getting treated, and talking to your provider and partners about options to protect your sexual wellness can keep you safe and healthy."

Having an STI can increase your chances of acquiring HIV, according to Dr. King, who adds that anyone who is having sex should learn about their options to prevent STIs and HIV, including testing, condoms, and PrEP, the medication that prevents HIV.

2024 NFL Draft: Top prospects, storylines to watch ahead of Thursday's first round

The Chicago Bears are expected to take USC QB Caleb Williams at No. 1, but what follows?

The first round of the 2024 NFL Draft takes place Thursday at 8 p.m. in Detroit, a night that could alter the future of many franchises. The Chicago Bears, Washington Commanders and New England Patriots own the top three selections, and many speculate those picks going to quarterbacks, which has happened three other times, most recently in 2021.

USC signal-caller Caleb Williams is all but certain to go No. 1, so the intrigue officially starts Washington. Which quarterback will the new general manager, Adam Peters, take? That's just one of the many storylines to watch on ABC, ESPN or the NFL Network.

Is Williams guaranteed to go to Chicago?

Nothing is guaranteed until NFL Commissioner Roger Goodell steps up to the podium and reads his name but, essentially, yes.

Williams, the consensus top prospect, threw for 3,633 yards, 30 touchdowns and five interceptions last season. He won the Heisman Trophy as the best player in college football the prior year after taking the Trojans from four wins to an 11-win team. Williams threw for 4,075 yards, 37 touchdowns and only four interceptions over 13 games in 2022.

Commanders do at No. 2? Like the Bears, the Commanders have been desperate for a franchise quarterback for more than three decades. There was a

glimmer of hope with Robert Griffin III, the 2012 NFL Offensive Rookie of the Year, but multiple injuries over the next seven seasons led to an early exit from the league. Will this finally be Washington's chance to turn around the

The Commanders have a new owner in Josh Harris and a new general manager in Peters, and both have been tight-lipped on whom they might select. But all signs point to either LSU quarterback Jayden Daniels or University of North Carolina quarterback Drake Maye.

The 6-foot-4, 210pound Daniels won the 2023 Heisman Trophy after one of the most electrifying seasons in college football history. He threw for 3,812 yards, 40 touchdowns and only four interceptions, while also adding 1,134 yards and 10 touchdowns on the ground.

Maye, at 6-foot-4 and 230 pounds, boasts the prototypical size for the position and has drawn comparisons to Los Angeles Chargers signalcaller Justin Herbert. After being named 2022 ACC Player and Rookie of the Year as a sophomore, he threw for 3,608 yards, 24 touchdowns and nine interceptions as a junior.

University of Michigan quarterback McCarthy, who led the Wolverines to their first national title since 1997, is also reportedly being considered.

Patriots could look to trade down

New England is still looking to find a replacement for legendary quarterback Tom Brady, who left the franchise in 2019. Mac Jones, a first-round pick in 2021, looked promising as a rookie but saw production drop off over the last two seasons. He was dealt to the Jacksonville Jaguars this offseason.

The Patriots signed Jacoby Brissett, though he's not expected to be the long-term starter. Will they instead take whoever is left among Daniels, Maye and McCarthy? If not, a trade down with a team such as the New York Giants, Minnesota Vikings or Las Vegas Raiders could be in play.

It would allow the president, with intelligence agency input, to designate social media applications controlled by foreign adversaries as national security threats. Despite bipartisan support for the bill, with House Speaker Mike Johnson (R-La.) describing Communist China as America's most significant geopolitical foe using technology to undermine the U.S. economy and security, it faced notable opposition: fifty Democrats

Republicans, 15 including Reps. Pramila Jayapal (D-Wash.), Ro Khanna (D-Calif.), and Marjorie Taylor Greene (R-Ga.) voted against it.

Critics raised concerns over potential infringements on free speech and adverse impacts on small businesses. TikTok's broad demographic reach was highlighted, with over 834

The legislation's opponents, including TikTok, argue that it risks curtailing First Amendment rights and harming thousands of minority-owned businesses reliant on the platform. The company has launched an aggressive

Paul Tran, co-owner of a skincare company that attributes much of its success to TikTok, said, "You will be destroying small businesses like us; this is our livelihood." He cautioned lawmakers against undermining the American Dream cherished by many.



Mary J. Blige and A Tribe Called Quest are among the Rock & Roll Hall of Fame class of 2024. The Rock Hall has announced one of its most significant inductions yet, with the R&B queen and hip-hop legends joining a prestigious roster that includes Kool & The Gang, Cher, Foreigner, Dave Matthews Band, Peter Frampton, and Ozzy Osbourne.

"This diverse group of inductees each broke down musical barriers and influenced countless artists that followed in their footsteps," John Sykes, chairman of the Rock & Roll Hall of Fame Foundation, said.

Blige, a multi-talented inspiration from the Bronx, New York, has long cemented her place in music history. Many said her journey is a testament to transformation and empowerment. A global superstar, Blige has eight multi-platinum albums, nine Grammy Awards, two Academy Award nominations, and a SAG nomination to her name.

Blige entered the scene at 18 when she signed with Andre Harrell's Uptown Records in 1989, and introduced a unique blend of hiphop, soul, and raw, honest lyrics by drawing inspiration from music legends like Aretha Franklin, Chaka Khan, and Gladys Knight. Her 1992 debut album, "What's the 411?", featuring chart-topping hits like "You



Love," marked the beginning of her storied career, captivating audiences worldwide. Meanwhile, A Tribe Called Quest, formed in 1985 in St. Albans, Queens, New York, has been hailed for their revolutionary contributions to hip-hop. Comprising Q-Tip, Phife Dawg, Ali Shaheed Muhammad, and Jarobi White, the group reshaped the genre with their innovative sound and socially conscious lyrics.

Throughout the 1990s, A Tribe Called Quest delivered a series of iconic tracks, including "Can I Kick It," "Check the Rhime," and "Scenario," solidifying their

Despite facing challenges, including the tragic loss of Phife Dawg in 2016, the group continued to push boundaries, releasing their final album, "We Got It from Here... Thank You 4 Your Service," in 2016. A year later, they received the 2017 Brit Awards for International Group before officially disbanding.

The Rock & Roll Hall of Fame's Class of 2024 induction ceremony is scheduled for October 19 at the Rocket Mortgage Fieldhouse in Cleveland, Ohio. Fans can catch the event live on Disney+, with an airing on ABC to follow and availability on Hulu the next day.

U.S. Coast Guard Promotes First Black Female Admiral

U.S. Coast Guard Capt. Zeita Merchant has made history as the first Black female admiral in the service's 233-year history. Admiral Merchant, previously the commander of Sector New York, will now lead the Coast Guard Personnel Service Center in Washington, D.C., where she will oversee recruitment and scholarships.

Merchant said she initially joined the Coast Guard with the intention of financing her medical school education. "I always had this passion for service, but I never thought it would be in the form of military service. I really feel like this is God's plan and not my plan," she told the Clarion Ledger newspaper in Jackson, Mississippi.

Officials said the promotion highlights the Coast Guard's ongoing commitment to diversity and inclusion. Historian William H. Thiesen notes that African Americans have played a pivotal role in the Coast Guard's history since its inception in 1790. "From the earliest days of the U.S. Revenue Cutter Service, Black sailors served alongside their white counterparts, with many making significant contributions during conflicts such as the Quasi-War with France and the War of 1812," Thiesen wrote in a column for the Coast Guard's newsletter.

He wrote that the Coast Guard's rich and illustrious history of African American service is filled with bravery and accomplishment milestones. From Aaron Carter, the first African American to die in combat defending the Cape Florida Lighthouse in 1836, to "Hell Roaring" Mike Healy, the first African American commissioned officer and ship's captain, Black Coast Guard members have consistently broken barriers and paved the way for future generations.

During World War II, the Coast Guard led the federal government's first official experiments in desegregation, commissioning its first African American officers and assigning Black officers and enlisted men to the USS Sea Cloud. By the war's end, 5,000 Black members had served in the Coast Guard, with one in every five reaching petty officer or warrant officer levels.

In the following decades, African Americans continued to achieve notable milestones within the service. Thiesen asserted that Lovine Freamon and Bobby Wilks became the first Black graduates from Officer Candidate School in 1954 and 1956.

Merle Smith, the first African American graduate of the Coast Guard Academy in 1966, later received the Bronze Star Medal for his service in Vietnam.

Modern times have seen African Americans reach even greater heights within the Coast Guard. Vince Patton became the first Black Master Chief Petty Officer of the Coast Guard in 1998, followed by Erroll Brown, the first Black flag officer, in 2002. Jeanine McIntosh earned her wings as the first African American female aviator in 2005, and in 2009, Felicia Thomas became the first Black female to command a cutter.

Merchant's distinguished career features key roles such as Special Assistant to the 27th and 28th Vice Commandants of the Coast Guard, Congressional Fellow for the Committees

on Oversight and Reform completed the Executive and Transportation and Infrastructure, and Executive Strategic Planner for the Coast Guard Flag and Senior Executive Service Corps.

Her educational background is equally impressive, holding a Doctor of Business Administration and a Master of Quality Systems Management from the National Graduate School at New England Institute of Business. She also earned a Master of Public Administration from George Washington University and a Bachelor of Science in Biology from Tougaloo

College. Additionally, Merchant truly yours to conquer."

Education Leadership in Homeland Security program at Harvard Kennedy School of Government and was a Seminar XXI National Security and Foreign Affairs Fellow at the Massachusetts Institute of Technology (MIT).
