

Trump 'rodent' tweets ring true at **Kushner-owned apartments**





BALTIMORE (AP) — Davon Jones doesn't have to look far to see the irony in President Donald Trump's tweets that Baltimore is a "rat and rodent infested mess." His apartment owned by the president's son-in-law has been invaded by mice since he moved in a year ago.

"I don't know how they come in," Jones says. "Every time I catch them, they come right back."

Jared Kushner's family real estate firm owns thousands of apartments and townhomes in the Baltimore area, and some have been criticized for the same kind of disrepair and neglect that the president has accused local leaders of failing to address. Residents have complained about mold, bedbugs, leaks and, yes, mice — plenty of mice. And they say management appears in no hurry to fix the problems.

"They don't care," says Dezmond James, who says he has spotted as many as three mice a week since he moved in to the Commons at White Marsh in suburban Middle River four years

James says he sees a massive contradiction in Trump's muchpublicized tweets laying the blame for Baltimore's poverty, crime and rodent problems on frequent antagonist Maryland Rep. Elijah Cummings. Trump, he said, should look more at what he and specifically Kushner — could do about it.

"His son-in-law owns all of this — then he can fix it. I'm pretty sure he has a lot of money," says James, who is studying to be a



medical assistant. "That's kind of weird that you want to talk trash. ... If you want to make improvements, you can make improvements."

Conditions got so bad two years ago that the Baltimore County government issued a release showing the Kushner Cos. had violated housing codes more than 200 times in just 10 months and only moved to fix the problems after being threatened with fines.

"I had black mold in my cabinets. I called them, I called them, I called them. And they never did anything," says Simone Ryer who moved out Whispering Woods in Middle River two years ago. "That was more than enough for me to leave."

In a statement, the Kushner Cos. said it was proud of its Baltimore-area apartments and has worked to maintain a "high quality residential experience for our tenants" by investing "substantial amounts" in upkeep.

A website for the Commons at White Marsh boasts of "amenities that amaze," but many of the 181 comments posted by residents at the review site apartmentratings.com complain of rats, mold, bedbugs, roaches and leaks. The reviews say management is generally unresponsive.

A 2017 report by the New York Times and ProPublica about residents at Kushner-owned developments echoed many of those online complaints, with one woman saying she found a mouse on her 12-year-old child's bed. The Kushner Cos. told the Times at the time that it is had spent \$10 million on its properties, but their age means issues can still arise.

A Baltimore Sun story the same year found the Kushner Cos.

used the courts to arrest tenants late on rent more than any other landlord in the state.

And a lawsuit seeking class-action status for residents alleges Westminster Management, the Kushner subsidiary that oversees rental properties in Maryland and other states, often charges tenants illegal and excessive fees that keeps them in constant fear of eviction and guessing what they owe. Westminster has said it has broken no laws and denies the charges.

Jared Kushner took in \$3.1 million from Westminster in the past two years, according to financial disclosure reports he filed with the federal government. He stepped down as CEO of parent company Kushner Cos. when he and his wife, Ivanka Trump, joined the White House as senior advisers to the president, but he still retains a financial interest and draws money from many of its operations.

At the Kushners' Dutch Village community in Baltimore, Ronald Newson says his 86-year-old mother, Carrie, has been asking maintenance staff for nearly a year to patch a hole in her ceiling from a leak on the second floor, and that someone has to come to kill all the mice she's been living with.

As a stopgap measure, she jammed the leg of a chair against a hole in the corner of her living room, but they kept coming out anyway. They also come from behind her stove.

"It takes them a long time to get repairs done," the son said. He suggested that Trump, instead of blaming Cummings for the city's problems, should look to landlords like Kushner, too.

"He talks about everyone but his son-in-law."

Tribe opposes Wyoming oilfield pollution proposal

CASPER, Wyo. (AP) - An American Indian tribe opposes a company's plan to dump oilfield wastewater upstream of a river in central Wyoming, saying the pollution could hurt business for fishing and rafting

Dallas-based Aethon Energy plans to put over 8 million gallons (30 million liters) of polluted water from the Moneta Divide oil and gas field into two creeks feeding the Wind River and Boysen Reservoir.

"Maintaining the environmental quality of these resources for current and future generations is essential," the Northern Arapaho Business Council wrote in a recent letter to state regula-

The Casper Star-Tribune reports the Wyoming Department of Environmental Quality is reviewing public comments on the plan, which also has raised U.S. Environmental Protection

Agency concerns.

The state agency has received some 450 comments on the proposal and will need some time to review them all, department spokesman Keith Guille said.

Dallas-based Aethon has said it would follow all regulations and offer more water protections than those required under previous permits. The company could treat the water more thoroughly than proposed, tribal officials

have said.

Beginning later this year when federal agencies submit proposed budgets to one or of the Appropriations Committees, those requests now must include a line item detailing what they are spending with minority-owned businesses, which include black-, womenand other minority-owned media outlets.

D.C. Democratic Congresswoman Eleanor Holmes Norton told NNPA each of the 12 federal Appropriations Committees have adopted language from her Government Advertising Equity Accountability Act [HR 2576], which mandates all agencies include in their annual budget request to Congress the amount of money they spend to advertise in minority-owned media outlets.

She said today's developments mean that her measure doesn't require further action. "This is exactly what we wanted. This is it, we got it," Norton said.

Norton asked for an update on a 2007 GAO report that found, of the \$4.3 billion available for advertising contracts, five agencies: the Department of Defense, the Department of the Treasury, the Department of Health and Human Services, the Department of the Interior, and the National Aeronautics and Space Administration, spent only five percent with minority-owned businesses.

A subsequent 2018 report Newswire on July 26, that revealed that, of the approximately \$5 billion government agencies spent on advertising contracts, just \$50 million went to minority-owned businesses and even considerably less to minority-owned newspaper and media companies owned by African Americans.

> "This is important not just for the publications but because those publications reach minorities and women in a way that mainstream publications may not," Norton said.

"We did this because the federal government is the largest advertiser in the "We got all 12 of the United States and this gives it a special obligation to make sure that it is using advertis-

States," said Norton, who has served in the U.S. House since

At the request of officials Publishers Association (Black Press of America) and the National Association of Hispanic Publications, Norton ordered a Government Accountability Office (GAO) examination on the spending on advertising contracts with minority-owned businesses.

Norton began a fight to change that.

She gathered support from other members of Congress and then, in May 2019, she crafted H.R. 2576 and continued to work behind the scenes to find more immediate solutions.

During budget hearings on Capitol Hill, Norton spearheaded a bipartisan effort for the 12 Appropriations Committees to place the language in their spending bills.

President Trump also urged Republicans to pass the budget bills - though, he had not specifically addressed Norton's measure.

By Thursday, 11 of the 12 committees had agreed to include the language with the Department of the Interior being the lone holdout. However, that changed on July 26, when she secured the commitment of Department of the Interior.

Despite her diligent work, Norton credited minorityowned media with the success of the legislation.

"I didn't just come up with this out of the blue, I credit Dr. Benjamin F. Chavis, Jr. [president and CEO of the National Newspaper Publishers Association], the Black Press of America, and the National Association of

all people in the United Hispanic **Publications** because they came to see me about this a couple of years ago," Norton said.

"They came to Congress to seek redress and I met with them, and then, having heard about what looked like a discrepancy, I needed to see if I could document that. So, I asked for the GAO report," she said.

Although the legislation does not mandate federal agencies to spend specific dollar amounts with minorityowned media companies, Norton said she believes publishers and owners of those publications ultimately will be pleased.

"Of course, I think they will start advertising because this is a big encouragement to do so," Norton said. "These are federal agencies under the jurisdiction of the appropriations committees, and they have to come before these committees each year to get their money. When they report back on how many dollars they spent with minorityowned and women-owned publications, they will understand that they will have to do just that and whatever they've done before they'll have to strive to do even better," Norton said.

"Once again the Black Press of America salutes the effecleadership Congresswoman Eleanor Holmes Norton," said Chavis. "Her diligence and commitment to diversity, inclusion and economic equity with respect to the Black Press and other minority-owned media across the United States is noteworthy and much appre-

FOR THE LAST TIME, GOD IS NOT SCHIZOPHRENIC

Let me state up front. This is not new. I heard something recently that has stayed with me and has rapidly become embedded in my spirit, so I thought it was worthy to again pass along to you. "God is not schizophrenic." It sounds simple enough, but, at closer inspection, you might want to seriously consider it implications.

When I looked for a biblical reference point, there were actually too many to quote. I mean the bible is full of confirmation regarding God's consistency. His unwavering faithfulness to us. God does indeed keep His promises and in His unpredictability, He is predictable.

God loves us no matter how hard we try to deny this. We can never remove ourselves from this truth. It/He never changes. Warts and flaws and faults, God loves us. That means you and all your hidden secrets too. Deal with it.

The problem with God's consistency is our inconsistency. When put into that perspective alongside God's steadfastas some kind of bizarre trick.

What I'm saying is our behavior can become unsteady and sinfully shaky. But our faith should not. In the context of our faith, the consistency of God's promise and His covenant with us should flourish. It should provide us with that proverbial 'rock' that we need to lean on.

Rangers get reliever from White Sox for 2 minor leaguers



ARLINGTON, Texas (AP) — The Texas Rangers have acquired right-hander Nate Jones from the Chicago White Sox for minor league pitchers Joe Jarneski and Ray Castro.

Chicago will send the Rangers \$750,000 as part of Wednesday's deal to cover part of the \$1.5 million remaining in the \$4.65 million salary for Jones, who is on the injured list after surgery to repair a flexor mass tear in his right forearm. He is not expected to pitch again this season.

Texas also will get \$1 million in international signing bonus pool allotment for 2019-20.

Jones had a 3.48 ERA in 13 relief appearances this season before going on the injured list April 27. He is 22-13 with a 3.12 ERA in 284 relief appearances in his big league career from 2012-19, all with the White Sox. His contract includes a \$3.75 million club option for 2020 with a \$1.25 million buyout, and also a 2021 option.

The 19-year-old Jarneski is in the Arizona League, and the 22-year-old Castro in the Dominican Summer League.

Dallas County Criminal District Attorney John Creuzot Re: Hemp/Marijuana Policy

(Dallas, Texas) – For more than a decade, the Dallas County Criminal District Attorney's Office has required a laboratory analysis prior to presenting a drug case to the grand jury for indictment. This policy protects innocent people from being wrongfully convicted. As your District Attorney, I have the responsibility to protect the rights of our citizens and ensure

that people are not prosecuted for possessing substances that are legal. After the recent change in law (HB 1325) the most notable dif ference between the unlawful possession of marijuana and the lawful possession of hemp is the concentration of THC present in the substance. The concentration of THC is a statutory element of an offense that we must prove to establish a person's guilt. Our office will not charge a person with a marijuana offense without a laboratory report stating that the substance has an illegal concentration of THC. HB 1325 was not confusing to the Dallas County Criminal District Attorney's Office. We thank Governor Greg Abbott for taking the time and effort to clarify what he obviously thought, and we agree, was a clearly written bill at the time he signed it into law.

Police have said Chemirmir posed as a maintenance worker or health care provider and stole jewelry and other valuables from his victims

His attorney has said Chemirmir maintains he's innocent.



Texas teenager accused of murder, rapes to be tried as adult

DALLAS (AP) — A Texas judge said she ordered a 16-year-old boy who's accused of killing a woman and raping at least four others in Dallas and Louisiana to be tried as an adult because the "public was indeed in need of protection" from the teen.

Dallas County Juvenile Judge Andrea Martin Lane told The Dallas Morning News that she prefers to seek a rehabilitative approach for teen offenders, but said the allegations against Lenario Jarvis Washington are so serious as to warrant prosecution as an adult.

The judge certified Washington as an adult on Wednesday. He's charged with crimes that include capital murder and four counts of aggravated sexual assault.

"I don't usually certify," she told the newspaper. "If there is a chance, then I'm most likely going to give them a chance."

The punishment Washington faces is much more severe if he's convicted as an adult. It's possible that he could be paroled after 40 years but a parole board may not allow it. A capital murder conviction can bring with it the death penalty but Washington won't be eligible because he's younger than 18.

Police have said Washington was seen as a suspect in part because the victims reported similar attacks: a suspect knocking on their door and asking for money or work, and then forcing his way inside while brandishing a weapon. He was linked to the November death of 23-year-old Maria Ezquerro because of the proximity of her apartment to where three other Dallas attacks occurred, police said.

Washington was living in Dallas at the time of his arrest and previously was living in Bossier City, Louisiana, when two women were attacked in separate incidents there, police have said. He was 15 at the time. While Washington is charged with four counts of aggravated sexual assault, authorities said they've tied him to two other assaults.

Bossier City is about 170 miles (273 kilometers) east of Dallas.

A Dallas attorney listed in court records as representing Washington, Phillip Hayes, did not return a message Monday seeking a response to the allegations.

The case is reminiscent of one in Oklahoma where 18-year-old Deonte Green was sentenced earlier this month to life in prison for fatally shooting a teacher, raping an 81-year-old woman and other crimes. Green was 16 when he committed the crimes, which included a series of armed rob-

beries, over the course of one day in October 2017. In sentencing Green, the judge said she found him "irreparably corrupt and permanently incorrigible," which is a standard in Oklahoma for imposing life without parole on a defendant who was a juvenile when a crime took place.
