# **Black Women Rally Behind Kamala Harris** to Save Democracy After Biden Steps Aside

Democrats and the rest of the nation are once again turning to Black women to lead the charge in saving democracy, and they have again stepped to the plate and swung for the fences. Following President Joe Biden's announcement that he would not run for the Democratic nomination, the network Win with Black Women organized a Zoom call to show how prepared and determined black women were to take on this enormous challenge. The call, held on Sunday, was a powerful display of unity and determination, with Black women leaders from across the nation voicing their unwavering support for Vice President Kamala Harris.

The Zoom call reportedly drew an astounding 40,000 attendees and featured an

The leaders passionately emphasized Black women's critical role in the upcoming election and shared personal stories about Harris that underscored her qualifications and leadership qualities. The rest of the agenda, as well as all campaign challenges that could block our President-to-Be, is up to us both now.



## Paul's Encouragement to Timothy in Facing a Difficult Problem I Timothy 1:1-20



I Timothy 1:1-20 may be outlined as follows: I. Paul's Advice Against False Doctrines – I Timothy 1:1-11; II. Paul's Acknowledging Testimony of God's Grace – I Timothy 1:12-17; III. Paul's Assertive Charge to Timothy – I Timothy 1:18-20.

#### I. Paul's Advice Against False Doctrines – I Timothy 1:1-11

In his opening greeting in verses 1-2, Paul identifies himself as an apostle of Jesus Christ; thus, his apostleship came to him by a heavenly command. Paul referred to Jesus Christ as our hope (v. 1). In verse 2, Paul referred to Timothy as the recipient of this epistle. Timothy was issued Paul's fairly standard greeting of grace, mercy and peace.

Paul admonished Timothy to remain in Ephesus to suppress certain men in the congregation who were teaching false doctrine. The doctrine the false teachers were teaching was different from Paul's doctrine (v. 3). The false teachers were teaching fables and long involved genealogies (v. 4). It is not known exactly what these fables and genealogies consisted of; however, the teaching regarding these fables and genealogies produced no spiritual value and led only to further speculation, questions, and arguments. Such speculation did not promote God's plan, which is conveyed only by faith.

In verse 5, Paul contrasts the false teachers and their ministry with that of the true minister of God's grace. The object of God's minister (steward) is to see people love one another, a love that comes from a pure heart, good conscience, and a sincere faith. Although love should be the goal of all Christian ministry, the false teachers in the Ephesus congregation had lost sight of this lofty purpose and had wandered away and turned aside to meaningless talk (v. 6). These false teachers were only promoting endless arguments, divisions, and empty talk!

In verse 7, these false teachers wanted to become competent and respected teachers of the Law, but they were completely incapable of doing so. These false teachers did not understand the Law or even what they were saying about it. In verse 8, Paul was not speaking against the Law, for he viewed the Law as "holy, righteous, and good" (Romans 7:12). Thus, Paul was conveying that the Law is good provided it is used properly. Paul explains to Timothy the significance of the Law. "God did not give the Law to save people, but to show people how much they need to be saved" (Romans 7:16).

In verses 9-10, Paul lists the sinners who are convicted and condemned by the Law, and if you compare this list with Exodus 20, you will discover that practically all of the commandments are included. God had entrusted Paul and Timothy with a glorious Gospel, not a system of Laws! (v. 11). Sound doctrine literally means "healthy teaching," that is, teaching that promotes spiritual health.

II. Paul's Acknowledging Testimony of God's Grace – I Timothy 1:12-17

Paul looked back to the time before he knew Christ, the time when he was a persecutor of the followers of Christ. He had been in the past in firm opposition to the gospel; now, Paul was thankful that he is a proponent of the gospel. He was once a persecutor, but now he is a preacher of the gospel. He was once a blasphemer of God's name, but now in his letter we find him blessing the name of God. The one who firmly hated the cause of Christ, now speaks well of the Lord.

Let us listen to some of Paul's doxological expressions. In I Timothy 1:12, he states: "Now, unto the King eternal, immortal, invisible, the only wise God, be honour and glory for ever and ever. Amen." Also in Romans 11:33-36, after Paul thought of God's mercy to Jews Or who hath first given to Him, and it shall be recompensed unto Him again? For of Him, and through Him, and to Him, are all things: to whom be glory for ever. Amen."

In Ephesians Chapter 3, after Paul had revealed the mystery of Christ which consists of both Jews and Gentiles being equal in the body of Christ, Paul exalted the name of God by saying: "Now unto Him that is able to do exceeding abundantly above all that we ask or think, according to the power that worketh in us, Unto Him be glory in the church by Christ Jesus throughout all ages, world without end. Amen."

Paul, in writing to Timothy in Ephesus, reminds Timothy that he received his calling directly from God. Paul thanked Christ for counting him faithful - for considering him worthy of the task (v. 12). Paul knew that God could have called others to do the same task. No one is indispensable to God.

Paul did not see himself as unique or a gift to God. Rather, God's work through Paul was unique and a gift to Paul. Paul was genuinely called during an appearance of the risen Christ on the Damascus Road (Act 9). Paul attributed his changed life to the unexpected kindness of God. Prior to his meeting the Lord on the Damascus Road, Paul admits that he was a blasphemer and persecutor (v. 13). He even admitted that he had harmed others. As a persecutor before Christ's intervention in his life, Paul wanted to wipe out all followers of Jesus. Paul was also guilty of harming others, and not just having people arrested.

Paul was an accomplice to Stephen being stoned (Acts 7:58). The ones who stoned Stephen threw their garments at the feet of Paul, who was referred to at that time as Saul. Stephen's execution by the ones who did the stoning was in full consent by Paul. But, Paul declares that his life of violent behavior was due to his ignorance. Had Paul known the truth that Jesus is Lord, he would not have done these

> coming to this earth was to save those who were lost. In verse 16, God's purpose in saving sinners was demonstrated in Paul being saved. Paul, who considered himself as the worse of sinners, served as a supreme example that other sinners may be saved. If God was patient and gracious enough to save Paul, He is patient and gracious enough to save anyone. All who follow can look back at Paul as a prototype or pattern. The ultimate sinner became the ultimate saint. God's greatest enemy became His finest servant

> (v. 17). Contemplating on the marvels of God's grace prompted Paul to give one of his great doxologies. Our Saviour is King Eternal ("the King of the Ages") - that conveys God's sovereignty over all history; He is "immortal and invisible" - that discloses two essential attributes of God, His eternality and His spiritual essence. He is "the only wise God"- that reveals his uniqueness as God. Our God alone deserves all honor and glory eternally, Amen.

III. Paul's Assertive Charge to Timothy – I Timothy 1:18-20

In verse 18, Paul resumed his charge begun in verse 3. Timothy's call and fitness for service in Ephesus was mentioned by a prophecy that confirmed Paul's conviction that Timothy was a fit soldier to combat the false teaching in the Ephesian church. There are two items mentioned by Paul for spiritual warfare in verse 19: faith and a good conscience. The word "conscience" means "to know with." Conscience is that inward judge that bears witness to our actions (Romans 2:15). It is possible for a believer to maintain orthodox doctrine while living in hidden sin, which can lead to spiritual shipwreck.

In verse 20, Paul named two men in Ephesus who would give Timothy trouble: Hymenaeus

and Gentiles, Paul broke forth in praise to God when he said: "O the depth of the riches both of the wisdom and knowledge of God! how unsearchable are His judgments, and His ways past finding out! For who hath known the mind of the Lord? or who hath been His counsellor? vicious acts! Now we find that God showed m

Now, we find that God showed mercy to Paul despite of his vile behavior (v. 14). Not only did Paul express his thankfulness to Christ (vs. 12-14), but Paul revealed God's thoughtfulness to all sinners (v. 15). In verse 15, Paul stated

## IN MEMORIAM: Democratic Congresswoman Sheila Jackson Lee Dies at 74

Democratic Congresswoman Sheila Jackson Lee, one of the longest-serving members of the Texas delegation, has died at the age of 74. In June, Jackson Lee announced her diagnosis of pancreatic cancer, yet she showed little indication of letting it interfere with her plans to run for a 16th term this November.

The fiery congresswoman disclosed her diagnosis in a written statement shortly after winning renomination in a fiercely contested Democratic primary. Known for her unwavering commitment to social justice, she was a fervent advocate for reparations for African

Americans and a vocal critic of the twice impeached and 34 times convicted felon and former President Donald Trump. Unlike some of her colleagues, she did not join the calls for President Joe Biden to step aside from the 2024 race.

As recently as Wednesday, 19, July Jackson Lee continued to champion President Biden's re-election campaign. "Something that does not get talked about enough: we were able to bring down homicides in Houston with federal investment," she wrote on X. "After President Biden signed the American Rescue Plan, we brought \$50 million to the city to

take on crime—and it these worked! Local/federal partnership saved lives." worke

She added, "This House Democrat believes Joe Biden has served us well and has the best plans for the future. I am laser-focused on beating Donald Trump and delivering for America because that's what matters." Jackson Lee also reminded her followers that America saw one of the most significant homicide spikes ever in Trump's last year in office. "He threw his hands in the air and did not know what to do," she asserted. "Since he left, I am proud that our American Rescue Plan has done the very important work to bring

these numbers down! Federal/local partnerships worked."

Jackson Lee's many legislative achievements are significant and wide-ranging. She played a crucial role in the passage of the Violence Against Women Act. She was a senior House Committee member on the Judiciary, Homeland Security, and Budget Committees. She was the first female ranking member Judiciary of the Subcommittee for Crime and Federal Government Surveillance, serving as Chair during the 117th Congress.

"A colored bag with pretty flowers or a clear spray bottle can be hard for children to ignore," said Lizbeth Petty, MPH, Public Health Education Manager at NTPC. "They may be curious or simply want to help their parents with gardening work, but these products can get on their skin, in their eyes, or they could swallow a harmful substance, resulting in serious injury."

Petty recommends familiarizing yourself with the major categories of household and garden products that can be harmful if not handled properly. Some potential poisons include pesticides, fertilizers, disinfectants, polishes and waxes, sanitizers, and detergents

The NTPC is available 24/7 to help advise callers during scary incidents. Following a few simple steps and educating your children to never touch or put chemicals in their mouths can help prevent poisoning from happening at home.

A few poison prevention tips to keep in mind include:

- Keep medicines and cleaning products in their original containers, properly labeled and stored up, away and out of reach
- Do not use food containers to store household cleaners, chemicals or hazardous products.
- Keep all laundry products locked up, high and out of the reach of children.
- Have working carbon monoxide detectors in your home near bedrooms and close to furnaces.
- Know what venomous snakes live in your area and wear proper attire (boots, etc.) when hiking outdoors or working in brushy areas in the garden.
- Check the label on any insect repellent and be aware that most contain DEET, which can be poisonous if used incorrectly.
- Be sure that everyone in your family can identify poisonous mushrooms and plants. Teach your children to "Always Ask First!" if they are unsure if something is harmful. Remember when it comes to poison ivy, "leaves of three, let it be,

Common disease outbreaks have


been vaccinated for Hepatitis B; Varicella; and Hepatitis A. Children in daycare must also be vacci-Diphtheria/Tetanus/Pertussis booster and Meningococcal vaccines are required for school. Immunizations during Walk-in-Wednesdays are available at Parkland's network of COPC health centers from 9 to 11 a.m. and 1 to 4 p.m., except for the following locations:

Obviously, she will answer "no," and steer you to a stunning stone that will cost you more than your first two cars. But that's OK...it'll get much better mileage.



### WNBA All-Star Weekend Highlights: Dallas Wings Arike Ogunbowale Wins MVP; Team WNBA defeats Team USA

were made. Records Records were broken. History was made. And a fun time was had by all at the 2024 WNBA All-Star Game.

Dallas Wings guard Arike Ogunbowale was named the 2024 WNBA All-Star Game Most Valuable Player after setting records for most points in a quarter, half and game.

She helped lead Team WNBA to the 117-109 win

over Team USA, which was made up of the WNBA players who will represent the USA in the Paris Olympics later this summer. TheAll-Star Game was held Saturday night at Footprint Center in Phoenix, Ariz.

Ogunbowale, who was making her fourth All-Star Game appearance, scored a single-quarter record 21 points in the third before

adding 13 in the fourth to finish with a record 34 points in the game. All 34 of her record-setting points came in the second half to establish a single-half standard.

Team WNBA trailed by two at the half, 54-52, before outscoring Team USA 36-25 in the third quarter, sparked by Ogunbowale. Team WNBA, which hadn't led since early in the second quarter, regained the lead at the 8:08 mark in the third off an Ogunbowale 3-points shot, and they led the rest of the game.

Following the conclusion of the game, Ogunbowale was named MVP, marking the second time she earned the award. Ogunbowale also earned the honor at the 2021 All-Star Game, which also featured a Team WNBA vs. Team USA format. She becomes the fourth player in WNBA history to earn multiple All-Star Game MVP trophies, joining Maya Moore (2018, 2017, 2015), Swin Cash (2011, 2009) and Lisa Leslie (2002, 2001, 1999).

Friday Night Skills Challenge

Before Saturday's Game,

the WNBA put on their Friday Night events which included the Skills Challenge and the 3-point competition.

Allisha Gray of the Atlanta Dream made history by becoming the first All-Star participant to win both the skills and 3-point competitions. The guard defeated Phoenix Mercury star Sophie Cunningham in the finals of the skills competition and New York Liberty center Jonquel Jones by one point in the shooting competition.

Grav, a former Dallas Wings player who was also the 2017 WNBA Rookie of the year, is also the first player to receive tons of cash during the All-Star weekend. The WNBA awards \$2,575 to each competition's winner as outlined in the 2020 collective bargaining agreement.

# Send Strong Message Against Trump

In an unprecedented display of unity and determination, over 50,000 Black men gathered on a Zoom call hosted by Roland Martin's Black Star Network, raising over \$1.3 million for Vice President Kamala Harris' presidential campaign. This powerful show of support came just a day after 40,000 Black women joined in a similar Zoom call, generating about \$2 million for Harris and sending a resounding message of solidarity and resolve.

The men's call, led by

Martin and co-hosted by

Bakari Sellers and others,

was a powerful statement

against former President

Donald Trump, who has

been twice impeached and

convicted of 34 felonies.

Martin, visibly moved, tweeted, "I have no words. And not just because I'm tired. My @BlkStarNetwork just told me that 53,862 people registered for our #WinWithBlackMen video call. We raised \$1.3 million and counting from 17,000 donors."

Bakari Sellers shared a poignant story that underscored Harris's compassion and unwavering support. He recounted a harrowing time in 2019 when one of his twin daughters was born with a rare liver condition. "The first person to call me was Kamala Harris. I am not sure people understand the pain and suffering that goes along with being a Black man in this country," Sellers said. "I am not sure people understand what it means to stand strong in this country. To have your back against the wall. But I am going to stand with her because she stood with me during my darkest moment when I almost lost my daughter. When I had to protect my wife."

The Zoom call resonated with the slogan, "We Rocking with Kamala Harris," reflecting the participants' unyielding support. This extraordinary event followed President Joe Biden's announcement that he would not seek the Democratic nomination, prompting the Win with Black Women network to organize a Zoom call showcasing their preparedness to back Harris.

The women's call drew an astonishing 40,000 atten-

dees and featured influential speakers such as Reps. Maxine Joyce Beatty, Waters, and Jasmine Crockett. These leaders passionately emphasized the vital role of Black women in the upcoming election and shared compelling stories about Harris that highlighted her qualifications and leadership qualities. Distinguished attendees included DC Mayor Muriel Bowser, Maryland Senate hopeful Angela Alsobrooks, civil rights leader Bernice King, and Black Voters Matter co-founder LaTosha Brown. In a less-publicized yet equally significant gathering, a large group of Black men and boys convened in Atlanta to discuss the state of America and the importance of Harris's candidacy against Trump in the 2024 election. These weekly discussions are critical for spreading accurate information and countering misinformation.

"The reason that we've gathered tonight is that there is so much misinformation, disinformation, that is being put out. So, we wanted thought leaders from across the political spectrum to come in tonight and talk directly to Black men about what they know, what they experience, and what some of the real statistics and facts are," said Attorney Mawuli Mel Davis, cofounder of the non-profit hosting these discussions. "That's critically important because the sources of our information are important for us to make sure that we're basing our decisions on good quality information."
