The White House planned to mark Juneteenth with a vibrant celebration on the South Lawn on Monday, June 10. The celebration would feature performances celebrated by African American artists, including Gladys Knight, Raheem DeVaughn, Patti LaBelle, Charlie Wilson, and Doug E. Fresh. Over 2,000 guests, including President Joe Biden and First Lady Dr. Jill Biden, were expected at the event, which officials said emphasized the Biden-Harris Administration's dedication to preserving and honoring African American history.

President Biden and Vice President Harris have prioritized advancing racial justice and recognizing Black history as an essential component ering highlighted ways the of American history. The monument in Washington fuses the portrait of a real-life individual with galvanized abolitionists for almost 100 years: a generic image of a kneeling enslaved person.

By now most Americans, but not all, have either heard of Project 2025 or seen some reference to it. But too many still don't know how this radical blueprint will change life in this country as we know it. The sad truth of the matter is the plan is hidden in plain view where we all can see it, but few are paying attention, other than those who have planned the changes.

The plan is called Project 2025, known as the Presidential Transition Project. This project will make widespread changes across our entire government in terms of economic and social policies and the role of the federal government and its agencies. The main idea behind these proposed changes, as put out by the Heritage Institute, is what is called an Executive

Theory, which asserts that the president has absolute power over the executive branch of our government under what is called "A Unitary Executive Theory interpretation of Article II of the Constitution of the United States."

This plan is designed for a "Republican President," as seen with the Donald Trump presidential candidacy for 2025. Under this plan, the following changes would take place, some immediately: (1) Slashing funding for the Department of Justice (DOJ); (2) Dismantling the Federal Bureau of Investigation (FBI) and the Department of Homeland Security (DHS); (3) Eliminating the Department of Commerce and ending the independence of various federal agencies such as the Federal Communications against discrimination based on sexual or gender identity; and (6) Termination of diversity, equity, and inclusion (DEI) programs as well as affirmative action.

Project 2025 advises the future president to immediately deploy the military for domestic law enforcement and to direct the DOJ to pursue Trump's adversaries by invoking the Insurrection of Act of 1807. It recommends the arrest, detention, and deportation of undocumented immigrants across the country. It promotes capital punishment and the speedy "finality" of such sentences.

Although the project does not promote a specific candidate, many contributors have close ties to Donald Trump and his presidential campaign. This project is proposed under what the Heritage Foundation calls its "Mandate for Leadership" and has been publishing this list of proposed changes to run parallel with each presidential election since 1981. It calls this Mandate its "Policy Bible".

Project 2025 has been developed in collaboration with over 100 partners. The Heritage Foundation president, Kevin Roberts, established Project 2025 in 2022 provide the to 2024

during his attempt to institute a Muslim travel ban, and his effort to install a new attorney general to help with his efforts to overturn the 2020 election.

Clearly the issue is not just Donald Trump, rather those who would use him or like-minded candidates for the Presidency to overthrow the United States government as it now exists with a Constitutionally based separation of powers. The only safeguard against this concrete plan to destroy America as it now exists is for "We the People" to prepare now to vote in the November election. We can no longer count on the United States Supreme Court which appears to have abandoned the very rule of law it was empowered to protect. It appears we can no longer depend upon the United States Congress which appears to have abandoned its legislative duties and oath of office by which the Republican members swore to "protect and defend the Constitution of the United States against all enemies, foreign and domestic" and substituted that oath with a commitment to a convicted felon. The question is: Where do we stand and for what will we fight?

b Esteem them highly. (Verse 13) - We

esteem those in authority by honoring their commitments to God's Word.  $\sim$  Romans 13:16-17

c Be at peace with one another. (Verse 13) – We are at peace with one another when we submit ourselves to the will of God. ~ James 3:13 - 4:10

d Warn the unruly. (Verse 14) – We warn the unruly by sharing God's Word with them.  $\sim$  II Corinthians 5:10-11

e Comfort the feebleminded. (Verse 14) – We encourage the fainthearted demonstrating our care for the weaker brother or sister. ~ Romans 15:1-3

f Support the weak. (Verse 14) – We support those that are weak in the faith by prayerfully receiving them.  $\sim$  Romans 14:1-3

g Be patient with all men. (Verse 14) – We show patience with others when we don't lose our temper.  $\sim$  James 1:19-20

h Don't fight one another. (Verse 15) – We should go about doing good instead of fighting one another. ~ Galatians 6:10

i Follow that which is good. (Verse 15)

– We overcome evil with good. ~ Romans 12:17-21

j Rejoice evermore. (Verse 16) – We can have joy as we encounter problems.  $\sim$  Nehemiah 8:10 and Galatians 5:22

k Pray without ceasing (Verse 17) – Prayer is heartfelt dependence upon God. We show our dependence upon God when we're praying constantly. ~ Luke 18:1

1 Be thankful in every thing (Verse 18) – We are thankful when we appreciate the great things God has done for us.  $\sim$  Philippians 4:4-7

m Quench not the Spirit (Verse 19) – When we quench the Holy Spirit, we are not listening to Him. Sin in our lives quenches the Holy Spirit~ Ephesians 4:30

n Despise not prophesying (Verse 20) – We are despising prophesy when we have a negative attitude toward studying God's word.  $\sim$  II Timothy 3:16-17; II Timothy 2:15

musical legends and underscoring the cultural importance of this federal holiday.

Harris declared June 19, 2024, one of three National Days of Action on Voting, focused on enhancing voter engagement and safeguarding the impact of such restrictions on civil rights. The White House Initiative on Advancing Educational Equity will host events emphasizing the importance of culturally relevant education.

The National Endowment for the Arts (NEA) plans to announce new recipients of the NEA Jazz Masters Fellowship, celebrating the contributions of African American musicians to jazz. The Institute of Museum and Library Services (IMLS) will highlight projects that preserve African American history as part of its "250: All Stories. All People. All Places initiative." The administration said it has significantly invested in preserving African American history through infrastructure and preservation projects. The Department of Interior's National Park Service (NPS) and the Historic Preservation Fund have allocated substantial funds for these efforts, including grants to support underrepresented communities and historic site nominations. Federal agencies, including the Department of Transportation, are working to document and uplift the stories of communities affected by past federal policies. The NEH prioritizes projects that preserve historical collections on slavery and its legacies. At the same time, the President's Committee on Arts and the Humanities will launch initiatives to support underserved creative and cultural communities.

My dad was there when I went to bed at night and was there when I woke up each morning. He was always there leading our family. Upon reflection, I probably took my dad's presence for granted.

I never had to wonder if my dad was coming home. It never occurred to me growing up that I would have to ask my mom where my dad was.

I did not have any doubts or trepidation about him being in my life. The life lessons he gave me back in the day have stayed with me to this day. He was a role model for me in every sense of the word. He passed away many years ago.

My dad, Dr. James B. Ewers, was a dentist in Winston-Salem NC. He was Jamaican and a graduate of the Howard University School of Dentistry in Washington DC. Afterwards, he moved to Winston-Salem NC and met my mom.

At the time, he was the only Jamaican in the city. I can't imagine what that was like. He then sponsored my cousin, Wilfred Ewers who became the second Jamaican in the city.

As I grew older, I began to see that my dad was greatly respected and admired. People saw him as a leader and a difference-maker.

There were always people at our house, some just seeking counsel and a good word. On the humorous side, some were also intrigued by his Jamaican accent. I found myself at times being an unpaid interpreter.

My dad was a big man with kindness and gentleness wrapped inside of him. He had character, integrity and honesty. I saw it on display every day. Yet as a boy, I probably could not have used those words to describe him.

Being from the West Indies gave my dad a keen sense of money and how to value a dollar. He also understood that not all his patients could pay him for his services.

There were occasions when he would take me horseback riding or bring food home. I later found out that these were his patients who didn't have the money to pay him.

I can remember like it was yesterday some of the long and exhaustive lectures that he gave me. I would sit on the couch, and he would begin.

It was important to him that I was respectful and that I not get into any trouble. I can recall his words, "Jimmy my boy, if you get into any trouble don't call me". As a young boy, you can imagine the thoughts I had when he uttered those words.

It made me apprehensive knowing that he meant what he said. Well, it worked. Would he have come to my aid? I believe so. However, I never had to find out. He was never called by any official at any level about his son getting into mischief.

Education was emphasized in my house. I always knew I was going to college because my parents talked about it very early in my life. It was simply where I was going.

There is not a day that goes by that I don't think about my dad. He gave me the foundation and the fundamentals for successful living. I am thankful to God that he blessed me with him.

Sunday, June 16th is Father's Day. If your father is living, I hope you celebrate with him and if he is not, remember him with fondness.

Funny how fast time


flies. Just when we understand school, we graduate. When we finally learn to comb our hair right, it falls out. And when we get our act together, there are no old friends around to watch the performance.





## First Black Racer in Porsche Carrera Cup **Competes at Formula One Miami Grand Prix**

MIAMI GARDENS, FLORIDA — When Jordan Wallace was a 5-year-old, his grandmother bought him a little, battery-powered Mercedes car. She may have regretted that move

because Wallace immediately hopped into his miniature whip and practically drove the wheels off it.

Convinced that Upper Marlboro, Maryland, had never produced a racer with his combination of aweinspiring speed and daring, Wallace began looking for pre-pubescent butts to kick.

"I tried to race the girl down the street in her Barbie Corvette, and she whupped me," Wallace said, still incredulous 31 years later. "And after that, I was like – I gotta get this figured out. Ever since then, I've been on a charge."

One that had Wallace swaddled in a helmet and Nomex driving suit as he blasted a 510-horsepower Porsche 911 GT3 Cup around the 3.36-mile, 19turn Miami International Autodrome road circuit, sounding like a bellowing, deep-voiced hound from hell.

Welcome to the Porsche Carrera Cup North America racing series, Jordan Wallace's world. He found himself onstage with the globe-trotting Formula One circus, which was in town for the Miami Grand Prix. Formula One promoters like to have other kinds of racing cars circulating tracks while F-1 cars are being

tweaked in their garages.

Wallace is an admirer of Formula One, but at 36 is too old to be dreaming about an F-1 seat. Instead, Wallace wants to move up to the Batmobile-like, fiendishly quick sports cars that compete in famous endurance races.

"The ultimate goal is to win the Daytona 24 Hours, the 24 Hours of Le Mans and the Sebring 12 Hours, and to be the first African American to win all of those," Wallace said. "I've got a ton of work ethic, a ton of desire and I think I'm showing that I'm pretty quick."

That last statement is all fact and no brag, because Wallace came within onehundredth of second of being the fastest qualifier for his Miami International Autodrome race. To put that in perspective, it takes the

average person between one-tenth to four-tenths of a second to blink their eyes.

A resident of Austin, Texas, these days, Wallace keeps a roof over his head with his racing activities, and by working as a driving instructor at a nearby race track. When it comes to the Kellymoss/Vision Motorsports Racing Porsche he's piloting in eight races this year, his sponsor is Davis Infrastructure, a Northern Virginia business that builds data centers.

"I grew up thinking race drivers were aliens because no one in my family, or in my culture, was in this sport," Wallace said. "Now I'm part-owner in the team that I'm driving for. Not only a Black driver but a Black owner. We're really trying to grow that side of the sport, as well."

the biggest difference in his health journey, Eisenger responded with immense gratitude for the role that education played.

"Parkland taught me a lot about my health beyond just diagnosing me. They explained everything from why things are happening, what to expect and how I can prevent my symptoms from coming back," he stated. "It gave me the confidence I needed to take control of my health."

The U.S. Centers for Disease Control and Prevention (CDC) states that heart disease is the leading cause of death for men in the United States,

followed by cancer. Prostate cancer is the second-leading cause of cancer death in American men, behind lung cancer. It's estimated that about 1 in 8 men will be diagnosed with the disease during their lifetime, according to the American Cancer Society.

"Eating a heart healthy diet and exercising regularly will reduce your cardiovascular risk, which is the risk of having a stroke or heart attack," Dr. Varkey emphasized. "Those healthy habits partnered with seeing your primary care doctor and engaging in preventive screening tests such as colonoscopies, prostate exams and regular lab tests will allow us to catch diseases and cancers early."

But anxieties and nerves revolving around health are always looming, especially when it comes to test results.

"Patients often tell me they don't want to do the screenings because they don't want to go looking for problems," Dr. Varkey shared. "I always tell them whether we do the screening or not, if there is something of concern it will cause symptoms down the line and at that point it could be too difficult to treat. These screening tests allow us to catch things much earlier and treat them in the least invasive way."

Dr. Varkey recommends that men of all ages get to

know their blood pressure, body mass index, cholesterol and blood glucose numbers. "This is information you receive during your annual physicals or checkups but being informed about your own numbers will help you track any changes and know when to bring up any concerns to your physician.

Parkland experts note that a regular visit to a healthcare provider should include risk assessments for future medical problems, screenings for cancer (including testicular, colon, prostate, skin and other cancers), vaccination updates and goal setting for a healthy lifestyle and diet.

Don't tough it out just

because you can. Dr. Varkey says it is always best to discuss any symptoms that are new to you as soon as they happen. The following are common symptoms that warrant a conversation with your doctor:

- Chest pain and/or shortness of breath - may be symptoms of a heart attack, pneumonia, pulmonary embolism, or asthma. If chest pain is sudden, severe or accompanied by other symptoms such as nausea, dizziness or shortness of breath call 911 right away.
- Fatigue may result from exhaustion, lack of sleep, or stress, but it

can also indicate congestive heart failure, diabetes, arthritis and other diseases.

- Vision problems while not always related to aging, they can indicate problems such as glaucoma, cataracts, diabetic retinopathy or macular degeneration.
- Change in bowel habits - could be a sign of food intolerance or an inflammatory bowel disease. Colon cancer screenings should also be considered.
- Changing moles any changes in a mole or freckle's size, shape, color or texture should be checked out by a dermatologist..

## Hunter Biden Convicted on Three Felony Charges Amid Political Turmoil

Hunter Biden, the embattled son of President Joe Biden, was found guilty of three felony counts of lying on a federal firearms application in 2018. At a crucial time for President Biden's reelection campaign, a Wilmington, Delaware, jury delivered the verdict.

Biden, 54, faced the jury grimly as the verdict was announced. The charges include lying to a federally licensed gun dealer, making a false claim on a federal firearms application, and possession of an illegally obtained gun from October 12–23, 2018. The offenses carry potential penalties of up to 25 years in prison, though first-time offenders in similar cases often avoid jail time if the weapon was not used in a violent crime.

The case centered on Biden's purchase of a handgun during a trying time in his life that included crack cocaine addiction, numerous rehab stays, divorce, financial difficulties, and associations with prostitutes. Despite these struggles, President Biden expressed unwavering support for his son in a heartfelt statement.

"As I said last week, I am the president, but I am also a dad," the president stated. "Jill and I love our son, and we are so proud of the man he is today. So many families who have had loved ones battle addiction understand the feeling of pride in seeing someone you love come out the other side and be so strong and resilient in recovery. As I also said last week, I will accept the outcome of this case and will continue to respect the judicial process as Hunter considers an appeal. Jill and I will always be there for Hunter and the rest of our family with our love and support. Nothing will ever

change that."

The incident is not the first time a president's family member has drawn attention. unwanted Notably, President Jimmy Carter's brother Billy was embroiled in scandal after becoming an agent for Libya under dictator Moammar Gadhafi, receiving substantial payments that sparked allegations of influence-peddling. During President George H. W. Bush's tenure, his son Neil faced scrutiny for his role in the Silverado Savings and Loan crisis, which resulted in a civil action and a \$50,000 settlement.

Similarly, Roger Clinton, the younger brother of President Bill Clinton, was a constant source of controversy, earning the Secret Service codename "Headache." He received a presidential pardon from his brother in 2001 for a previous cocaine conviction. Additionally, former President Donald Trump was famously convicted last month in New York on 34 felony charges related to a hush-money scheme involving an extramarital affair with an adult film star.

## Project 2025 and Election-Year Hate Group Spike Pose Risks for People of Color

People of color have made unprecedented progress in policymaking during the Biden-Harris administration. This has been overlooked in the misinformation, disinformation, and support of convicted felon and presumed GOP presidential nominee Donald Trump by welland influential known African Americans such as Ice Cube, Stephen A. Smith, Byron Donalds, Rep. Supreme Court Justice Clarence Thomas, Ben Carson, Sexxy Red, Snoop Dogg, Don King, Mike Tyson, Ye, Killer Mike, Azealia Banks, Lil Wayne, DaBaby, Kodak Black, Chief Keef, Benny the Butcher, and Waka Flocka Flame.

All that progress likely will come to a grinding halt if Trump and his far-right supporters, who are running on a dangerous manifesto, win reelection. Republicans and Conservatives want to take America back to the days of Jim Crow and beyond.

And those concerned say the proof is in the proverbial pudding as white nationalist and anti-Black, Hispanic, and LGBTQ groups have surged to record levels in the United States, fueled by the mainstreaming of hard-right politics ahead of a presidential election cycle, according to the Southern Poverty Law Center

The SPLC, which has published an annual report since 1990, documented 835 active anti-government groups, up 133 from 2022's count, and 595 hate groups, an increase of 72 over the previous year's figure. Notably, white supremacy hate groups saw a 50% surge in 2023, the highest jump ever recorded by the SPLC, growing to 165 from 109 in 2022. However, white power and neo-Nazi rallies across the U.S. decreased to 143 in 2023 from 191 in 2022.

The SPLC also noted a 33% rise in anti-LGBTQ organizations over the last year, bringing the total to 86.

"What we're seeing now should be a wake-up call for all of us," said Margaret Huang, SPLC's president and CEO, on a call with reporters. "Our 2023 report documented more hate and anti-government extremist groups than ever before. With a historic election just months away, these groups are multiplying, mobilizing and making, and in some cases already implementing, plans to undo democracy."

The SPLC reported an increase in in-person events and leafleting by hate groups, tracking nearly 7,000 flyer incidents last year, many featuring language derived from racist and antisemitic conspiracies.

These groups have also launched campaigns to gain influence in mainstream politics, notably through the conservative Heritage Foundation's Project 2025 manifesto which outlines aspirations for anti-abortion, anti-free press, and anti-LGBTQ priorities should presumed GOP presidential nominee and convicted felon Donald Trump win in November. Critics warn that

The comprehensive overhaul of the federal government outlined in the 900page "Mandate for Leadership" includes significant policy shifts and a reimagined executive branch, covering both domestic and foreign policies, a personnel strategy, and a 180-day playbook designed to "rescue the country from the grip of the radical left," according to the project's website.

"It is not enough for conservatives to win elections," the website states. "With the right conservative policy recommendations and properly vetted and trained personnel to implement them, we will take back our government."

Project 2025 has drawn criticism for its authoritarian nature, including during a recent House hearing on where Texas Democratic Rep. Jasmine Crockett challenged Gene Hamilton, one of the project's authors.

"It calls for eliminating the Department of Education, eliminating the Department of Commerce, and deploying the military for the use of domestic law enforcement against protesters under the Insurrection Act of 1807," Crockett said. "It also has the repealing of Schedule F status for thousands of federal employees to allow a president to replace career civil servants with unqualified partisan loyalists. It also prohibits the FBI from combating the spread of misinformation and disinformation like Russia and China who are actively trying to interfere with American elections."


Crockett condemned the plan, stating, "I don't know why or how anybody can support Project 2025... in the United States of America, dictatorships are never funny—and Project 2025 is giving the playbook for authoritarianism, as well as the next dictator, to come in."

Adding to the alarm, Trump declared he would be "a dictator on Day 1" if reelected.

Additionally, the Center for American Progress highlighted how Project 2025 would devastate local transit systems, particularly affecting communities of color and undermining economic growth. The plan proposes eliminating funding for the Federal Transit Administration's (FTA) core programs and discretionary Capital Investment Grants (CIG) program.

"Public transit is a vital component of our modern transportation system, providing affordable, safe, and efficient mobility to millions of Americans every day," said Kevin DeGood, director of Infrastructure Policy at CAP. "Project 2025 would badly harm local transit systems that support regional economies from coast to coast and increase costs for commuters."

Rep. Crockett's warning rings clear: "Project 2025 is giving the playbook for authoritarianism, as well as the next dictator, to come in."
