# House Oversight Committee Meeting Erupts in Personal Attacks and Partisan Disputes

#### By Stacy M. Brown

A nighttime session of the House Oversight Committee intended to discuss a resolution recommending Attorney General Merrick Garland be held in contempt of Congress descended into chaos amid personal attacks and partisan bickering.

The rare evening session took a contentious turn when MAGA Republican and rabid Donald Trump supporter Rep. Marjorie Taylor Greene of Georgia responded to a question from Rep. Jasmine Crockett (D-Texas) with a personal remark. "I think your fake eyelashes are messing up what you're reading," Greene incredulously lashed out.

Democrats immediately reacted negatively to the remark, with Rep. Alexandria Ocasio-Cortez (D-N.Y.) leading the charge. She demanded that the unhinged Greene retract her comments and offer Crockett an apology. "That is absolutely unacceptable," Ocasio-Cortez declared amid the crosstalk. "How dare you attack the physical appearance of another person?"

Greene, undeterred, taunted

Ocasio-Cortez, asking, "Are your feelings hurt?" Ocasio-Cortez responded sharply, "Oh, girl? Baby girl, don't even play."

Just minutes later, Greene, of all members, attacked Ocasio-Cortez's intelligence, challenging her to a debate and asserting, "You don't have enough intelligence." This prompted audible groans from other members.

During the contentious exchange, political pundits and others couldn't help but note the difference between Crockett and Greene, whom many on social media allege is a staunch racist. The Texas Democrat has routinely demonstrated her passion for justice and the protection of rights and has platformed criminal justice reform. Meanwhile, Greene remains a lightning rod for what's plaguing government servants. In March of 2022, numerous Georgia voters filed legal challenges to her reelection campaign, alleging that she was disqualified from public office because she helped to facilitate the January 6, 2021, insurrection.

# Plans to spend billions on a flood-prone East Texas highway may not solve the problem

LUFKIN — U.S. Highway 59, a major evacuation route from Houston, has been a problem for East Texas for decades. And as flooding rivaling that of Hurricane Harvey inundated the region in April, the highway closed in several places, cutting off a major evacuation route for countless people seeking shelter from the floods.

Plans to upgrade the highway, which stretches more than 600

miles through Texas from Laredo to Texarkana, to interstate standards have been on the books for decades. But the Texas Department of Transportation says it cannot guarantee that the billions of dollars being poured into the project will fix the flooding problem.

"U.S. 59 was one of the issues during [hurricanes] Rita, Ike, and Katrina," Polk County Judge

Sydney Murphy said. "So you think by now we would be committed to expanding that roadway."

Texas has poured millions of dollars over the past 30 years into upgrading parts of the highway to interstate standards — an effort known as the I-69 project — with the goal of relieving traffic congestion, supporting economic development, improving safety for travelers, and upgrading a major evac-

uation route for the state's most populous city.

Thus far, only the part of U.S. 59 that runs through Houston has been upgraded to interstate standards, with a minimum of two travel lanes in each direction, 12-foot lane widths and paved shoulders of a specific width on both sides.

Steps to upgrade the highway in other areas have focused on larger

population centers, such as Lufkin and Nacogdoches.

Portions of U.S. 59 between Cleveland and Shepherd as well as between Shepherd and Livingston saw significant flooding in April. Those stretches of highway were closed multiple times between April 29 and May 4 — then again when more heavy rain came the

# Dallas church thief sentenced to 35 years in prison in deed fraud scheme

The jury found Foster committed felony theft of \$300,000. The indictment combined the theft of the three churches into a single case.

Foster had earlier rejected a plea offer for a lesser punishment. He testified during the four-day trial in his defense.

"Stealing real estate is just as

much a theft as stealing someone's purse or car," prosecutor Phillip Clark told WFAA after the trial. "But it is much more complicated to unwind or fix."

Although Foster has been convicted, Clark said the churches are still having to untangle issues connected to the deed fraud.

"The Canada Drive Christian Church congregation was completely booted out of their church building," Clark said. "In the case with Lancaster, they are still trying to fix all the problems he created. Nineveh and Canada are still in his

or his church's name."

Besides the three churches, the Dallas County jury heard evidence during the punishment phase of the trial that seven other properties – mostly church buildings or lots owned by churches - had similar "hallmarks" of deed fraud.

# The Rapture (Introduction)

I Thessalonians 4:13-18

Part 1

We come now to Paul's grand exposition on the subject of the Rapture of the church. It had come to Paul's attention that there was a grave concern on the part of the believers with respect to what would happen to their Christian loved ones who died before the advent of the Rapture. Paul had taught vigorously that Christ's advent (His coming for His saints) could happen at any time. As you would recall, since Paul's departure from them, there had been a number of them who had died before the Lord came. The question that pervaded their minds was: "Will our loved ones experience the bliss of this grand event (Rapture), or would they remain in the heart of the earth?

Paul certainly had to dispel any doubts that the believers had with regard to their loved ones' relationship to this event by informing them that both groups - the translated saints, as well as the dead in Christ saints will experience the joy of the event. Paul had to labor hard

to correct the misunderstanding that these believers had regarding their loved ones' inclusion in the Rapture experience. As ministers of God, we are called upon to always be ministering from these perspectives: the ministry of edification, exhortation, and comfort (I Cor. 14:3). Our Christian associates need to know that the Rapture is the next eschatological event on God's calendar, and that all believers since Acts Chapter 2 (the birthday of the church) will participate in that event.

The Rapture will take place before the advent of the Tribulation period (I Thess. 1:10; Rev. 3:10; I Thess. 5:9). By the word, "eschatology," I am referring to the "doctrine of future things." As it relates to the future, the Rapture will take place prior to the Tribulation period, which will last for seven years. It will be a time of unusual punishment the unbelieving world will experience (Amos 5:18-20; Zephaniah 1:15). Thank God that all people - regardless of the color of their skin or of their plight in life - can have the blessed assurance that they will experience the Rapture (being caught up in the Mid-Air to meet Jesus) if, and only if, they would believe the simplicity of the Gospel message (I Cor. 15:1-4).

The Gospel message includes the death, burial, and resurrection of Jesus Christ. The moment that any man, woman, boy or girl genuinely accepts the Gospel message in their heart, they are saved (John 3:36, 5:24, Romans 10:9). Accept the Lord, right now in your heart, and I will assure you that based on God's Word, you are saved! And once you are saved, you are saved forever from the wrath to come (Tribulation Period - I Thess. 5:9).

The classic passage on the Rapture of the church (I Thessalonians 4:13-18) begins in verse 13 with Paul referring to the Thessalonian believers as brethren. He refers to these believers as brothers, denoting their equality of standing before God. Moreover, Paul is not berating these believers for their lack of knowledge on the subject of the Rapture, aware that they were new converts. The major subject matter in verse 13 deals with Christians who have fallen asleep. The figure of sleep is emblematic of death.

The type of death that Paul refers to is the death of the body. This reference to death never refers to the soul or the spirit of man, because the spirit of man does not die. Paul wanted the Thessalonians to be neither ignorant nor grieving like the rest of men, that is, like unbelievers, over the death of fellow believers. Paul never instructs the Thessalonian believers not to grieve over the passing of their loved one; however, we are not to grieve as those who have no hope of being bodily raised to glory with Christ. Again, to grieve as believers is a normal experience, for even our blessed grieved (St. John Lord 11:35).

According to verse 14, there are two reasons why

Christians should not grieve as unbelievers: (1) Christians have a revelation from God that offers them hope; (2) Christians have a blissful future with Christ. Paul states emphatically that the souls of believers who have died will return with Christ when He come for His living saints. Thank God that the death and resurrection of Jesus Christ are two authentic facts of history. Also, the prophecy of the Rapture of the church is certain to be fulfilled as the prophecies of Christ's death and resurrection.

Paul clearly conveys in verse 15 that there will be saints who will be alive during the Lord's return. Paul believed that the Rapture was imminent, meaning that it could take place any moment (I Thessalonians 1:10). On the subject of the Rapture, Paul wanted these believers to know that their dead loved ones who died before the blissful event of the Rapture will be a part of it!

Paul stated that believers who are alive and remain unto the coming of the Lord shall not prevent (or precede) those believers who have died in Christ. Believers who are alive at the coming of the Rapture will not be going ahead of those who died in Christ.

According to verse 16, Christ's return from His lofty position in heaven (Romans 8:34; Ephesians 1:20; Colossians 3:1; Hebrews 1:3) for His saints will be dramatic indeed! The dead in Christ of this dispensation of grace will be raised! Believers of this church age will be raised (believers since Acts Chapter 2 until the Rapture) and not the Old Testament saints who will be raised at the end of the Tribulation Period (Daniel 12:2) to inherit the Millennium.

The great mystery of how God will raise the bodies of people poses a problem to the faith of countless ones. Our God who created the universe out of nothing (ex-nihilo) with a fiat is fully able to reassemble the decayed dead bodies of all His saints in a moment of time (I Corinthians 15:35-58). After the bodies of those who have died in Christ have been raised (v. 16), then those who are alive and remain will be caught up with the dead in Christ to meet the Lord in air (v. 17).

By using the word "we" Paul included himself, thinking that Christ would return during his lifetime. The resurrected or translated bodies of all Christians will be united with Christ and with each other at the Rapture. The Lord will take us to the place He is presently preparing for us (St. John 14:2-3). As lofty as this subject of the Rapture is, Paul wanted these believers to encourage one another with these words (v. 18).

In the midst of the prevailing problems and issues of our present lifetime, it is awfully comforting to know that the Rapture of the church is an imminent event, and that fact should inspire us to say: "Even so, come Lord Jesus!" (Revelation 22:20).



**OPPORTUNITY FOR A CONTESTED CASE HEARING** You may request a contested case hearing. The applicant or the executive director may also request that the application be directly referred to a contested case hearing after technical review of the application. A contested case hearing is a legal proceeding similar to a civil trial in state district court. Unless a written request for a contested case hearing is filed within 15 days from this notice, the executive director may act on the application. If no hearing request is received within this 15 day period, no further opportunity for hearing will be provided. According to the Texas Clean Air Act § 382.056(o) a contested case hearing may only be granted if the applicant's compliance history is in the lowest classification under applicable compliance history requirements and if the hearing request is based on disputed issues of fact that are relevant and material to the Commission's decision on the application. Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for contested case hearing to the Commissioners for their consideration at a scheduled Commission meeting. The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material air quality concerns submitted during the comment period. 





# **Diddy in Crisis: Abuse Accusations** and a Strange TV Appearance

Sean "Diddy" Combs' former head of security, Roger Bonds, revealed he witnessed the hip-hop mogul being violent toward women "four or five times," expressing no surprise at the 2016 footage of Combs brutally beating then-girlfriend Cassie Ventura.

"It didn't surprise me when I saw it because I've seen things of this nature before," Bonds said in a televised interview this week. "I've gotten in between things like this back in 2012." He described the 2016 incident where Combs was seen shoving, kicking, stomping and dragging Ventura in a hotel hallway.

When asked how many times he'd seen Combs become violent toward women, Bonds replied, "Around four or five times." He added, "I've seen him [be violent] with Cassie and Kim Porter, his kid's mother. I've seen him

get physical, grabbing them up and getting into wrestling and punching matches."

Combs apologized for the 2016 incident in a recent Instagram video, calling his behavior "inexcusable" without directly addressing Ventura. "I take full responsibility for my actions in that video. I'm disgusted," he said.

However, Ventura's lawyer, Meredith Firetog, criticized Combs' apology, calling it self-serving. "Combs' statement is more about himself than the many people he has hurt. He only apologized after his repeated denials were proven false," she said.

In a separate incident, rapper Cam'ron, also known as Cameron Giles, appeared on CNN with Abby Phillip to discuss the developments surrounding Combs. However, the interview went awry as

Cam'ron seemed unaware of the topic and focused on promoting his product, an all-natural sexual supplement called HorsePower. After making non-committal remarks about the security footage, Cam'ron asked his team off-camera, "Who booked me for this joint?"

# Plans to spend billions on a flood-prone East Texas highway may not solve the problem

weekend of May 16 — and are supposed to receive upgrades in the next four years.

Those sections are part of nearly \$6 billion the state plans to pour into the highway over the next decade or more to upgrade the highway to interstate standards, address safety issues and cover basic maintenance. TxDOT says it has allocated \$1.5 billion for projects already underway or that begin soon on U.S. 59. The agency has another \$4.3 billion allocated for future projects scheduled to begin in the next four to 10 years.

"East Texas in general has experienced a large increase in extreme rainfall compared to last century," Nielsen-Gammon said. "Part of that is due to climate change. Climate change has increased the intensity of very heavy rainfall across the southern U.S. by nearly 20%."

TxDOT would not say whether current improvement plans take into account warnings from climatologists of even more severe flooding to come

Laura Butterbrodt, another TxDOT spokesperson, said the agency is currently developing the Statewide Resiliency Plan, "which will specifically target critical routes for the most appropriate design, maintenance and operations to foster resilience."

The first draft will be available for review by the Resilience Steering Committee in June.

When the federal government authorized building 41,000 miles of interstate highways crisscrossing the nation in the 1950s, the federal government paid 90% of the cost, leaving the remaining 10% to the states.

But the I-69 project was not included in the original plans and didn't receive federal designation until the early 2000s, state Sen. Robert Nichols said. When completed, the interstate will stretch more than 2,600 miles across multiple states from the Texas-Mexico border to the Michigan-Canada border.

"The projects being developed along the future I-69 corridor are designed to be serviceable for a 100year flood event, however TxDOT cannot predict the amount of rain or potential flooding our lakes, rivers and streams could see in the future," said Rhonda Oaks, the public information officer for TxDOT's Lufkin District, where plans are currently underway to upgrade around a proposed interstate highway is expected to cover the cost — not the federal government.

"At present, there is no dedicated federal funding for the entire conversion of U.S. 59 to a future I-69 route through Texas," the Federal Highway Administration said in an email statement. "It is up to the State [Texas Department of Transportation], to move projects forward."

Despite agreeing to strike her comments toward Crockett, Greene refused to apologize for her remarks. "You will never get an apology out of me," she declared. Committee Chair James Comer (R-Ky.) ruled that Greene's insult did not violate House rules, which led to further disputes. When Democratic ranking member Jamie Raskin (D-Md.) attempted to appeal this ruling, Republicans moved to table his appeal.

on the committee's standards regarding personal attacks. "If someone on this committee then starts talking about somebody's bleach blond, bad-built butch body, that would not be engaging in personalities, correct?" she asked, causing another uproar.

The controversy moved Comer to admit, "I have two hearing aids. I'm very deaf. I'm not understanding – everybody's yelling. I'm doing the best I can."

Comer later agreed to strike Greene's insult of Ocasio-Cortez from the Democrats record, and pushed to enforce rules that would prevent Greene from speaking for the remainder of the hearing. However, Republicans voted to allow her to continue speaking. After a short recess, Comer reminded members to adhere to the House's standard of decorum.

Greene was ultimately

Crockett sought clarification recognized to speak for over four minutes, reiterating her refusal to apologize. "I will not apologize for my words, and I will not change them," she said.

- 60 million people in the U.S face the day-to-day reality of living with a mental illness.

# Parkland experts remind you to 'take the moment' to prioritize mental health

• mental illness each year, and only twothirds receive treatment. • 1 in 6 U.S. youth experience a mental health condition each year, and only half of them receive treatment. Mental health disorders include psychotic disorders like schizophrenia, mood disorders like depression and bipolar disorder, personality disorders, post-traudisorder matic stress (PTSD), substance use, anxiety, and eating disorders, among others.

"Acknowledging your emotions and seeking support are the first steps toward managing your symptoms effectively," said Natasha Benatti, PsyD, Trauma Psychologist at Parkland Health. "It's essential to create a safe space where you can express your feelings without judgment. This might involve confiding in a trusted friend, family member, or seeking professional help from a counselor or therapist."

According to NAMI data, half of all lifetime mental health conditions begin by age 14 and 75% by age 24, and early intervention programs can help. If you have a mental health condition, you're not alone. As with other illnesses, mental illness is not your fault. With proper treatment, symptoms can be dramatically reduced and many people with mental health conditions will succeed in leading active, fulfilling lives.

In addition to working with a health professional, practicing mindfulness and relaxation techniques can also help significantly alleviate stress and anxiety. Engaging in activities such as deep breathing exercises can help calm the mind and promote inner peace. Carolina Pena, Licensed Professional Counselor, Mental Health Therapist at Parkland Health emphasizes the importance of incorporating these practices into your daily routine. "Consistency is key. Even just a few minutes of mindfulness each day can make a significant difference in managing stress levels," said Pena.

Maintaining a healthy lifestyle is another important way to prioritize your mental health. Regular exercise not only improves physical health but also releases endorphins, which are natural mood lifters. Additionally, prioritizing nutrition and getting an adequate sleep can help you build resilience against common stressors.

Establishing boundaries and learning to say no when necessary is essential. Overcommitment can lead to burnout and worsen feelings of stress and anxiety. Learning to prioritize tasks and delegate responsibilities when necessary can help alleviate the burden. Pena advises, "Setting boundaries allows you to preserve your energy and focus on activities that truly matter to you."

Additionally, fostering meaningful connections and engaging in activities that bring joy and fulfillment are vital for maintaining your mental well-being. Whether it's spending time with loved ones, attending church or spiritual gatherings, or volunteering in your community, developing a support network can provide a sense of belonging. Pena encourages individuals to "Foster relationships that uplift and support you. Connection is a powerful remedy for stress and anxiety."

The 988 Suicide & Crisis Lifeline is a 24/7 call, text, and chat service where people can access trained crisis counselors. Those experiencing suicidal thoughts, substance abuse or any emotional distress can receive support, which is especially helpful for people wanting to remain anonymous. The line also offers support to those who are worried about a loved one and need crisis support.

The staff in Parkland's Behavioral Health Services staff is here to support, offering a range of mental health services provided by trauma-informed psychiatrists, behavioral health providers, clinical social workers, psychiatric nurses and psychologists.

# Potential Hurdles Ahead, but Biden Still Holds Strong Support Among Black Voters

Despite endorsements and praise for former President Donald Trump from high-profile African American figures like Stephen A. Smith, Snoop Dogg, and Ice Cube, President Joe Biden continues to enjoy strong support within the Black community. A new Pew Research Center study, "An Early Look at Black Voters' Views on Biden, Trump, and Election 2024," highlighted this trend, showing that a majority of Black voters believe Biden possesses the qualities needed for another term.

Black voters remain overwhelmingly negative. The study found that 72% of Black voters rated his presidency as poor or terrible, and 65% believe the twiceimpeached and four-times indicted Trump broke the law in his alleged efforts to overturn the 2020 election. Despite this, 49% of Black voters express a desire to replace both Biden and Trump with different candidates if given the option.

The priorities of Black voters diverge somewhat from those of the general electorate. While the economy is a top concern for 73% of Americans, Black Americans place equal importance on improving the education system (79%) and ensuring the financial stability of Social Security (74%). Other key issues include reducing healthcare costs (72%), addressing poverty (70%), reducing crime (68%), and tackling racial issues (65%).

Biden's job performance approval among Black Americans has seen some improvement. As of April 2024, 55% approve of his handling of the presidency, up from the near-even split in January 2024. This approval, however, is still below the 87% recorded early in his term.

Looking ahead to the 2024 election, 55% of Black voters believe the outcome is crucial as Trump's plans include a dictatorship and a complete erosion of rights for all people of color, according to his biggest supporters' "Project 2025" plan. Currently, 77% lean towards voting for Biden, while Trump garners support from 18% of Black voters, with younger Black voters more likely to support Trump compared to their older counterparts.

Confidence in Biden's capabilities remains relatively high among Black voters, with 56% believing he respects democratic values and 50% confident in his ethical conduct. Only a small fraction extends these beliefs to Trump, with no more than 8% attributing similar qualities to him.

However, the Biden campaign could face significant challenges if it fails to engage adequately with the Black Press of America. The Black Press, celebrating its 197th anniversary in Baltimore next month, continues to play a crucial role in reaching Black voters. Reflecting on a similar situation in 1992, President Bill

Clinton faced backlash for reneging on a promise to address the Black Press at their annual convention. Ironically, that convention was held in Baltimore, the same city that's hosting the 2024 conference.

"Clinton later made up for it by inviting the Black Press to the White House for a discussion, a move that helped him secure the presidency," stated Philadelphia Tribune Publisher Robert Bogle, who famously led a press conference during that 1992 convention to denounce Clinton's absence. Bogle and Houston Defender CEO Sonny Messiah Jiles, who also help lead the 1992 presser, told the Black Press' Let It Be Known morning news show that, if Biden neglects to address the Black Press or invest in significant advertising, his campaign risks alienating a

critical voter base.

Overall, Biden still maintains a substantial lead among Black voters, but Jiles and Bogle said his campaign must navigate carefully to maintain and strengthen this support. "Addressing the Black Press and focusing on the community's unique priorities will be essential steps in securing their votes in the upcoming election," Bogle asserted.
