Voting is one of our most fundamental rights. It's not just about having a say in the future of our country, it's about honoring the legacy of those who fought and sacrificed so that we

could have a voice. As a voting

hand, and how deeply un-American it is when folks cannot vote because of arbitrary barriers put in place to make it harder.

I became a voting rights attorney because I believe the right to vote is preservative of all other rights. That's why we cannot afford to sit on the sidelines. In

Congress, I've been working to reinstate and modernize the Voting Rights Act to stop harmful voter suppression laws here in Texas and across the country. To give more Texans a chance to participate in our democracy, we must expand early voting, make Election Day a federal holiday, and take steps like same-day voter registration that make voting more accessible, not create barriers that are harmful to our democracy. I've introduced legislation that would ensure integrity in our elections and protect our election workers. I stand by the words of my hero, Congressman

John Lewis who said "The vote is precious. It is almost sacred. It is the most powerful non-violent tool we have in a democracy."

Despite these efforts, laws like S.B. 1 in Texas make it harder for Texans to vote by mail,

Colin Allred, Ted Cruz blast each other as "extreme," throw jabs on border and abortion in Senate debate

The debate proved combative from start to finish, with Cruz and Allred trading barbs on nearly every issue that came up.

DALLAS — U.S. Sen. Ted Cruz and his Democratic challenger, U.S. Rep. Colin Allred, sparred Tuesday over immigration, abortion and transgender rights in a feisty debate that is expected to be the only onstage face-off between the two candidates ahead of the Nov. 5 election.

Throughout the onehour debate, Cruz cast Allred as "radical and extreme," repeatedly urging the audience to consider Allred's voting record over his efforts to portray himself as a moderate. He sought to tie Allred to Vice President Kamala Harris, alleging the two "voted in favor of open borders over and over" and were both responsible for fueling a surge in inflation under the Biden administration.

"We're doing an awful

DALLAS — U.S. Sen. lot right in the state of Ted Cruz and his Democratic challenger, U.S. Rep. Colin Allred, sparred Tuesday over immigration, lot right in the state of Texas," Cruz opened the debate. "Colin Allred wants to change that. I want to keep Texas, Texas."

Allred countered by attacking Cruz as a partisan bomb-thrower with few legislative accomplishments to show for his nearly 12 years in office. He blasted Cruz for helping spike a bipartisan border package earlier this year and said the GOP senator was "only focused on himself," invoking Cruz's trip to Cancún in 2021 as Texas was paralyzed by a historic winter storm.

"He's never there for us when we need him," Allred said. "When the lights went out in the energy capital of the world, he went to Cancún. When a mob was

Harris responded to a voter from Georgia who feared Trump would use the Alien

Enemies Act of 1798 to detain people of color. "Bobby," the voter, expressed worry that Trump would "put anyone that doesn't look white in camps."

"You've hit on a really important point and expressed it, I think, so well," Harris said. "He is running full-time on a campaign that is about instilling fear. Not about hope, not about optimism, not about the future, but about fear."

Harris went on to criticize Trump's claims that immigrants in Springfield, Ohio, were eating their pets. She also accused him of sabotaging a bipartisan border security bill that would have added border agents and targeted fentanyl trafficking. "He would prefer to run on a problem instead of fixing a problem," Harris stated.

Democratic strategist James Carville earlier voiced his concerns, comparing Trump's tactics to those of Nazi Germany. Speaking on MSNBC's Inside with Jen Psaki, Carville warned that Trump's planned rally at Madison Square Garden on October 27 was reminiscent of a pro-Nazi event held there in 1939. During that rally, which drew 20,000 supporters, swastikas were displayed alongside a portrait of George Washington, while speakers promoted anti-Semitic views.

Carville cautioned Americans about the dangers of

another Trump presidency: "They're telling you they're doing all of this. This is not something we're making up. They have promised military round-up." He emphasized the Harris campaign's need to clarify the severe threats Trump could pose.

Trump recently stated on Fox News's Sunday Morning Futures that he might deploy the National Guard or military forces to prevent "radical left lunatics" from causing unrest on Election Day. "It should be very easily handled by, if necessary, the National Guard, or if really necessary, the military," he said.

Others have echoed Carville's concerns. In June, MSNBC host Rachel Maddow questioned whether camps under a Trump administration would be limited to migrants, saying, "What convinces you that these massive camps he's planning are only for migrants?"

New York State Senator Brad Hoylman-Sigal has called on Madison Square Garden to cancel Trump's rally, stating, "Allowing Trump to hold an event at MSG is equivalent to the infamous Nazi rally at Madison Square Garden on February 20, 1939." He urged the venue to "keep our city safe."

With three weeks until Election Day, Carville made his final plea: "Pay attention to them right now, please. They're telling you."



Paul will advise Titus to appoint elders so that the churches will be properly organized and managed; but more importantly, Paul will stress to Titus that each age group mentioned in Chapter 2 (aged men and women, young men and women, and servants) must exhibit the proper character and conduct that is consistent with the profession of their claimed faith in God.

In addition to Titus' responsibility to properly

organize the churches, there was also a grave need that he refute the false teachers in Crete who were guilty of distorting the truth of the gospel (1:10-16). These false teachers were guilty of subverting sound doctrine; a problem that is still prevalent among us today! We need more trouble-shooters today as a Titus who will stand firm and rebuke false teachers in their aim to against sound "healthy" doctrine. The

limit the hours of early voting and have burdensome voter registration, and voter ID provisions. This isn't who we are as Texans. The Voting Rights Act, championed by the civil rights movement, was signed into law by a great Texan, President Lyndon B. Johnson.

I think about other Texas icons like the late, great Congresswoman Barbara Jordan, who fought fearlessly for our democracy. She never shied away from challenging those who wanted to silence our communities and take away folks' voices in our democracy. She said it best: "What the people want is very simple, they want an America as good as its promise."

To live up to that promise, we must do better.

Ted Cruz wants to take our democracy backward, as we all saw on January 6 when he tried to overturn a free and fair election and disregard the will of the American people. Ted Cruz supports restrictive laws based on fear tactics about widespread voter fraud. storming the Capitol, he was hiding in a supply closet. And when the toughest border security bill in a generation came up in the United States Senate, he took it down."

The debate, held at WFAA-TV's studio in downtown Dallas, proved combative from start to finish, with Cruz and Allred trading barbs on nearly every issue that came up. In his opening statement, Allred called Cruz "maybe the most extreme" member of the Senate in the last 30 years. Cruz closed with the message that Allred "wants to destroy what we've got in Texas because he shares Nancy Pelosi and Kamala Harris' values."

The debate began with a focus on Texas' abortion ban, which does not exempt cases of rape and incest. Allred has made restoring abortion access a key part of his campaign, while Cruz has largely avoided the issue. Pressed Tuesday on where he stands on the question of rape and incest exceptions, Cruz said the matter should be settled at the state level and declined to stake out a position. He went on to criticize Allred for pinning the issue on him in his TV

"You know, Congressman Allred is running all sorts of ads saying that I made this decision," Cruz said. "I don't serve in the pete in state Legislature. I'm not sports. the governor."

Allr

Allred has leaned into the state abortion ban in the homestretch of the election, running ads that highlight the stories of women who were forced to leave the state after being denied emergency medical care for pregnancy complications. He brought up the issue again Tuesday evening, disputing Cruz's characterization of himself as

"you're not pro-life,"
Allred said, turning to address Cruz. "It's not pro-life to deny women care so long that they can't have children anymore. It's not pro-life to force a victim of rape to carry their rapist's baby. ... Understand that when Ted Cruz says he's pro-life, he doesn't mean yours."

yours."

Allred was put on the defensive later when he was asked about a series of ads run by Cruz and his allies accusing the Dallas Democrat of supporting legislation that would allow men to use women's restrooms and boys to play in girls' sports.

The ads cite Allred's vote against the Protection of Women and Girls in Sports Act of 2023, a GOP bill that would cut off federal funds for athletic programs that allow men, "based solely on a person's reproductive biology and genetics at birth," to com-

pete in women's or girls' sports.

Allred characterized the attacks as a "Hail Mary" and a "desperate" attempt to deflect from Cruz's stance on abortion, calling it "laughable" for the GOP senator to say he wants to protect women.

"What I think is that folks should not be discriminated against," Allred said. "What Senator Cruz should try to explain to you is why he thinks they should."

Cruz dug into Allred for supporting a 2021 bill called the Equality Act, which would have barred gender discrimination in public places, including based on if a person is transgender. He blasted Allred for recently signing onto a letter, along with dozens of other House Democrats, that urged GOP lawmakers to strike from an annual defense policy bill provisions that include "restricting medically necessary care for transgender service members" and restricting the use of pride flags on bases.

"You know what he argued for? Military bases should have drag shows and should be able to fly a transgender flag above it," Cruz said. "Call me old-fashioned — I think the only flag that should fly above our military base should be the American

Parkland focuses on prevention this National Latino AIDS Awareness Day

Expands testing, PrEP, and education to combat HIV disparities in the Latino community

DALLAS – In observance of National Latino AIDS Awareness Day (NLAAD), Parkland Health is prioritizing awareness, education and access to essential HIV prevention services while addressing the disproportionate impact of HIV on Latino communities in Dallas County.

NLAAD is observed annually on October 15. The theme for this year is "Get Tested, Get Treated, Get in Control."

Despite advances in treatment and prevention, the Latino community faces significant disparities as it relates to HIV. While Latinos account for 32% of the population in Dallas County, a large majority of new HIV cases are among Latino and Hispanic individuals, according to Susana M. Lazarte, MD, infectious diseases specialist at Parkland and Associate Professor of Medicine at UT Southwestern Medical Center. Nationally, 32 % of new HIV diagnoses were among Latinos with demographic only making up 18% of the general U.S. population.

Many of these diagnoses occur at a late stage, often when individuals have already progressed to AIDS. This increases their risk for complications and mortal-

"Increased awareness and education are crucial to HIV prevention," said Dr. Lazarte. "While testing is important, Parkland's efforts go beyond that. It's about teaching the community that early diagnosis and access to preventive care like PrEP can change lives."

PrEP (Pre-Exposure Prophylaxis) is a medication taken daily or via bimonthly injection that significantly reduces the risk of contracting HIV by preventing the virus from establishing an infection in the body. It's a crucial tool in HIV prevention, especially for individuals at higher risk, as it offers an effective way to stay protected before potential exposure.

Parkland has intensified its HIV prevention strategies across the health system, including expanding access to PrEP, offering HIV education and prevention at all Community Oriented Primary Care (COPC) locations and conducting screenings at Access to Care Pop-Ups, during community outreach activities and in Parkland's Emergency Department. In line with the U.S. Centers for Disease Control and Prevention (CDC) recommendations, Parkland now offers HIV testing as part of routine care for every adult patient, with a goal of early diagnosis and intervention.

"Latino communities face barriers when it comes to accessing preventive care like PrEP due

to factors like insurance, stigma and access to care," Dr. Lazarte stated. "We see stigma in the Latino community at levels reminiscent of the 1980s. Many still believe they're exempt from risk, but HIV can affect anyone."

Parkland experts recommend every individual be tested at least once in their lifetime in accordance with the U.S. Prevention Task Force recommendations, as well as every time they have a new sexual partner. Patients can also ask their general practitioners for a test during their routine checkups any time they feel they could use one.

Dr. Lazarte and her team recognize that cultural factors and stigma often prevent Latino individuals from seeking care. She says healthcare providers play a critical role in breaking down these barriers by normalizing conversations about sexual health.

Armando Quiroz, HIV test counselor at the AC-CESS clinic in Parkland's Moody Outpatient Center, focuses on bilingual outreach, specifically in the Latino community. Parkland's outreach initiatives include health fairs, community-based organizations, academic institutions and faith-based munities in Parkland's priority ZIP Codes.

"We have a great col-

laboration with our community health workers and our community partners that are all involved in our commitment to end the HIV epidemic," Quiroz said. "We're aiming to reach the multigenerational Latino community and empower them with education about sexual health, a topic that they have historically viewed as taboo but should be as routine as checking your blood pressure."

Cowboys hope 'battle tests' now can pay off later

FRISCO, Texas — Battered and bruised, both physically and in the realm of pride, the Dallas Cowboys are entering their bye week at the perfect time. They've won three games on the road, the most recent being a gritty win to overcome all manner of adversity against the Steelers in Pittsburgh, but they've also lost three at home, with the blowout loss to the Detroit Lions technically serving as the fourth consecutive humbling at AT&T Stadium.

They've been outscored to tune of 53-119, very near a historical worst in points allowed at home through the first three games of an NFL season, and have shown both a refusal to die and an unwillingness to live in a span of only seven days.

All of this plays into who the Cowboys are currently, but with 11 regular season games remaining to right the ship, it's at least possible that the early-season adversity might pay itself forward as the season rolls along — as stated by offensive coordinator Brian Schottenheimer.

"We're getting battle tested, and that's the thing," he said of the sixgame body of work. "One of the things that's happening right now is we're being battle tested. We are. We're finding out a lot about ourselves and our grit.

"It's not just the young players that we're talking about — it's all the players. We'd like to get that stuff now, so that when the games get bigger and bigger, and on

a bigger stage, you feel equipped to handle it."

Being ravaged by injury as of late is one reason for the struggles, but not the excuse, considering there were issues (e.g., red zone offense, run defense) that present themselves before the injury bug sunk its fangs into the roster over the past couple of weeks.

It has, however, created opportunities for role players to get a lot of reps they may otherwise not have received, helping to forge them for the winter to come.

There's good to be gleaned from the first six games, but there's far more bad and, sitting at .500, you are indeed what your record says you are. The next couple of weeks will give the Cowboys an opportunity to gut check themselves to prevent other teams from having to do it for them as the calendar turns its pages.

"I don't think there's ever been a bad time for a bye week," said head coach Mike McCarthy. "I just think the fact that this game is challenging. It's a 17-game season, so I get it. When a schedule comes out, you look at how it lines up. But, just based on where we are, as far as injuries and things like that, I think it's, it's a good time for a bye."

And, on the other side

of that bye, they will say hello to another big test — a familiar one, no less — when they travel to meet the 49ers in Santa Clara.

"We have studies that we do, a big project that we'll do with our players when they get back," McCarthy added. "So that's all about continuing education and really just staying on top of it. I think we need to do better. We got work to do, obviously."

Three tests passed, but none were aced. Three tests failed, and not many showed up, mentally, to take the last one.

And now it's time for midterms.

What does it mean if my voter registration is in "suspense"?

If a county receives a non-deliverable notice after sending a voter registration certificate or suspects an address change, a voter is placed on the "suspense list" and asked to confirm their address. Voters on the suspense list can still vote (https://www.votetexas.gov/faq/registration.html) if they update or confirm their address before the voter registration deadline or fill out a "statement of residence" when voting, but they may have to vote at their previous polling location or vote on a limited ballot. If a suspended voter takes no action, they are removed from the voter rolls after about four years, according to the Texas Secretary of State's office.

Federal law prevents the state from removing registered voters within 90 days of a federal election unless the voter has died, been convicted of a felony or been declared mentally incapacitated.

If you're concerned about your voter registration, you can verify it online (h t t p s : / / t e a m r v mvp.sos.texas.gov/MVP/mvp.do).

What if I moved after the voter registration deadline?

You must reside in a Texas county by the voter registration deadline to vote in the upcoming election unless you qualify for absentee voting. You can read more about absentee and mail-in voting here (https://www.texastribune.org/2024/08/2 1/texas-voter-guide-2024election/#86c18fcc-3e2d-4af6-947eba4b98cefe9d.)

You can vote at your previous polling location if you moved within the same county or political subdivision. Or you can vote at your new polling location on a ballot limited to the elections you would qualify to vote in at both polling locations, such as statewide races. But limited ballots are available only during early voting at a "main early voting polling place," which is usually the office of the election administrator or county clerk who runs elections in your county. The

Eligible people experiencing homelessness can vote as long as they provide on their registration an address and description for where they are residing, such as a shelter or a street intersection. If needed, their mailing address can be different, but a P.O. Box address is usually not considered a residence address.

What do I do if I run into issues with my voter registration?

Inside polling locations, there are typically "resolution desks" where poll workers can address registration issues.

What do I need to know about mail-in voting?

How do I know if I'm eligible to vote

This option is fairly limited in Texas. You're allowed to vote by mail if:

- You will be 65 or older by Election
- Day. • You will not be in your county for the entire voting period, including
- early voting. · You cite a sickness or disability that prevents you from voting in person without needing personal assistance or without the likelihood of injuring your health.
- You're expected to give birth within three weeks before or after Election Day.
- You are confined in jail but otherwise eligible (i.e., not convicted of a felony).

If you are voting absentee, such as from out of the state, and want to see what will appear on your ballot, you can get a sample ballot from your county. Sample ballots can be found on your county's election website in most cases. If you are voting from overseas, what appears on your ballot may depend on how you fill out your application to vote by mail and when you submit it. What identification do I need to vote by mail?

Texas' rules require voters to provide an ID number on both their application for a ballot and the carrier-envelope used to return a completed ballot. This must be one of the following ID numbers:

- A driver's license number
- A state ID number
- The last four digits of their Social Security number
- A Texas election ID certificate number (this would be found on a photo ID issued by DPS and is different from the number found on your voter registration certificate)

If they don't have any of these, voters can also check a box indicating they have not been issued any identification.

This identification rule was added by the Texas Legislature in 2021, and some voters have had their ballots or applications rejected because they didn't provide an ID number or the number they provided did not match the one the state had for them.

If you don't have a license number on you provided, the secretary of state has suggested contacting your local voter registrar to ask about how to add one of the required numbers to your voter registration record.

Other voting advocates have suggested voters include both their driver's license or state ID number and the last four digits of their Social Security number, if they have both, to avoid is-

Does lack of immunity to COVID-19 qualify as a disability?

While a lack of immunity to COVID-19 alone does not allow a voter to request a ballot based on a disability, the Texas Supreme Court ruled in 2020 that it was up to voters to decide if that lack of immunity, combined with their medical history, meets the state's eligibility criteria.

The Texas election code's definition for disability is broader than other federal definitions. A voter is eligible to vote by mail if they have a "sickness or physical condition" that prevents them from voting in person without the likelihood of "needing personal assistance or of injuring the voter's health." It's up to the voter to decide this, and election officials don't have the authority to question a voter's reasoning.

What kind of postage do I need to return my mail-in ballot?

It depends on where you live. Postage for mail-in ballots will vary by county because the style and size of the ballot could be different from county to county — and some counties may pay postage for you. Local elections offices should have specifics once ballots are finalized. That said, if you don't have enough postage, your ballot should not be returned to you. Instead, the Postal Service is supposed to deliver the ballot and bill the county for the insufficient or missing postage.

Houston ISD superintendent didn't illegally funnel state money to out-of-state schools, TEA says

The Texas Education Agency found that checks mailed to Miles' charter school network in Colorado were eventually deposited into the network's Texas account.

The Texas Education Agency has cleared Houston school district Superintendent Mike Miles of wrongdoing after he was accused of improperly diverting millions of dollars in state funds to his Colorado charter school system.

After reporting from Spectrum News and The Texas Observer prompted calls for an investigation earlier this year, the education agency concluded on Tuesday that neither Miles — who the agency picked to lead the state's largest school district last year nor his charter school network, Third Future Schools, "violated any applicable Texas laws," according to the 29-page investigation report.

The investigation found, in part, that checks directed from a partnering Texas school district to Third Future Schools' Colorado address went there because the Colorado location handles accounting services for the network's Texas branch, which is run independently. But, the checks were eventually deposited in the Texas branch's bank account.

"Based on the evidence obtained and analyzed during the investigation, there is no merit to the allegations contained in the media reports that state funds were being inappropriately diverted from public school students in Texas," the report notes.

The agency is closing the investigation, and "no further action will be taken" at this time, the report says.

In an email sent to the Houston school district community on Tuesday, Miles called the earlier reporting "a baseless distraction and an attempt to undermine and discredit the good work happening" in the schools.

"Now we can do what we always do and move forward on behalf of our students," Miles said.

Earlier this year, Spectrum News reported that the Texas branch of Third Future Schools — which receives funding from multiple Texas school districts to run campuses in the state — was potentially using public funds from its school in Odessa to offset financial losses at a sister school in Colorado.

Miles denied wrongdoing and accused the previous reporting of mischaracterizing "common place financial arrangements between charter schools and the charter management organizations that support them" and welcomed an investigation into the network's activities.

The state's investigators agreed with Miles, saying they found no evidence that Texas school districts deposited funds into the bank account of Third Future Schools in Colorado. Third Future Schools-Texas reimburses the Colorado location for administrative services it provides to all of the charter network, the report says.

The report also states that there is generally no state or local policy requiring Third Future Schools-Texas to disclose any agreements with the Colorado office regarding the purchasing of services, though it adds that there was no effort to hide the partnership from Texas school districts.

The allegations "cannot be substantiated, or have been proven to be false," the report says.

Miles has been a polarizing figure since the Texas Education Agency charged him and an unelected school board with taking the helm of the Houston school district last year. Rationalizing the takeover, the state pointed to misconduct by the previous board

and the unsatisfactory academic performance rating of Wheatley High School located in Houston's Fifth Ward, where an overwhelming majority of students are Black and Hispanic and reside in low-income households.

Under Miles' leadership, the district has experienced extraordinary staff turnover and plummeting student enrollment. Miles has faced accusations of shepherding a militarystyle schooling environment where teachers have limited freedom to teach in ways they see fit and children are exhausted and disengaged from learning.

Miles, on the other hand, has touted student improvement on the state's standardized tests as proof that his model is effective, an achievement that Texas Education Agency Commissioner Mike Morath has also publicly acknowledged and commended. In November, Houston voters will decide on whether to approve \$4.4 billion in academic and infrastructure improvements for school district largest proposal of its kind in state history — which some see as a litmus test for Miles' support among the public.

Enemies Act of 1798 to detain people of color. "Bobby," the voter, expressed worry that Trump would "put anyone that doesn't look white in camps."

"You've hit on a really important point and expressed it, I think, so well," Harris said. "He is running full-time on a campaign that is about instilling fear. Not about hope, not about optimism, not about the future, but about fear."

Harris went on to criticize Trump's claims that immigrants in Springfield, Ohio, were eating their pets. She also accused him of sabotaging a bipartisan border security bill that would have added border agents and targeted fentanyl trafficking. "He would prefer to run on a problem instead of fixing a problem," Harris stated.

Democratic strategist James Carville earlier voiced his concerns, comparing Trump's tactics to those of Nazi Germany. Speaking on MSNBC's Inside with Jen Psaki, Carville warned that Trump's planned rally at Madison Square Garden on October 27 was reminiscent of a pro-Nazi event held there in 1939. During that rally, which drew 20,000 supporters, swastikas were displayed alongside a portrait of George Washington, while speakers promoted anti-Semitic views.

Carville cautioned Americans about the dangers of another Trump presidency: "They're telling you they're doing all of this. This is not something we're making up. They have promised military round-up." He emphasized the Harris campaign's need to clarify the severe threats Trump could pose.

Trump recently stated on Fox News's Sunday Morning Futures that he might deploy the National Guard or military forces to prevent "radical left lunatics" from causing unrest on Election Day. "It should be very easily handled by, if necessary, the National Guard, or if really necessary, the military," he said.

Others have echoed Carville's concerns. In June, MSNBC host Rachel Maddow questioned whether camps under a Trump administration would be limited to migrants, saying, "What convinces you that these massive camps he's planning are only for migrants?"

New York State Senator Brad Hoylman-Sigal has called on Madison Square Garden to cancel Trump's rally, stating, "Allowing Trump to hold an event at MSG is equivalent to the infamous Nazi rally at Madison Square Garden on February 20, 1939." He urged the venue to "keep our city safe."

With three weeks until Election Day, Carville made his final plea: "Pay attention to them right now, please. They're telling you.

Cruz also faced questions at the debate over his comments regarding the attack on the U.S. Capitol on Jan. 6, 2021. Cruz at first called the events a "violent terrorist attack," before walking back the comment, calling it "sloppy" and "frankly dumb." Cruz, asked about his changing stance, turned the issue around on Allred.

"Congressman Allred is happy to talk about those who committed acts of violence on Jan. 6, but you don't hear him talking about the Antifa and Black Lives Matter riots that burned cities across this country," Cruz said, referring to protests in the wake of George Floyd's death at the hands of a Minneapolis police officer. "If you commit an act of violence, you should go to jail, and there should be no political favoritism in that regard."

Allred sought to refocus the discussion on Cruz's role surrounding certification of the 2020 election, in which he urged colleagues to object to the certification of results in some states and called for a 10-day audit to probe unsubstantiated voter fraud claims in the disputed states. Allred said Cruz was "a threat to democracy" and recalled the harrowing events of the

day, when members of

Congress were told to "look under our feet for gas masks."

Both candidates have portrayed themselves as moderates willing to work across the aisle, each touting crossover support from politicians in the opposing party. Allred's GOP supporters include former U.S. Reps. Liz Cheney and Adam Kinzinger, both of whom are among their party's leading critics of former President Donald Trump. Cruz, meanwhile, has garnered the endorsement of Harris County District Attorney Kim Ogg, who was defeated in the Democratic primary earlier this year. Ogg is the most prominent member of the

"Democrats for Cruz" coalition assembled by the GOP senator to soften his reputation as a partisan bomb-thrower.

Cruz likened Allred's answers to Harris and his voting record to that of former U.S. House Speaker Nancy Pelosi. In response, Allred accused Cruz of making a "recent transition to trying to be someone who wants to actually get things done."

Allred noted that he is a past recipient of the Jefferson-Hamilton Award for bipartisanship from the U.S. Chamber of Commerce, which Cruz noted has endorsed him in the Te

Senate race. ments in favor of a limited After the debate, Glen regulatory environment

Whitley, a Republican and former Tarrant County judge who recently announced his support for Allred, said Cruz's approach to the 2020 election was part of why he is supporting the Democratic nominee. He argued that Allred performed especially well on the topic of Jan. 6, and on immigration.

"It's a heck of a thing when you see the Democrat winning the discussion on the border over a Republican," Whitley said.

Cruz strategist Sam Cooper said his candidate "pushed forward a positive vision for the state of Texas," citing Cruz's arguments in favor of a limited for oil and gas and other industries, and his "record of bringing jobs" to the state.

"Congressman Allred is Kamala Harris. Their record is no different," Cooper said. "When the congressman was pressed on his record, time and time again he refused to answer."

Most recent polling has shown Cruz leading Allred by around 3 to 5 percentage points, though a few surveys have found the race to be even tighter. Allred is hoping to close the gap in the final weeks after campaign finance reports showed he had outpaced Cruz in fundraising over the last few months.

Relief Efforts Are Happening In Florida And Other States Despite What The Former President Says

In my years of service to our community, both on the Dallas City Council and as a lifelong social justice activist, I have never witnessed a threat to our rights as alarming as the one we face today.

Proposition T threatens to erase that legacy. It aims to hand over control of our city to an undemocratic survey of just 1,400 people which would allow for the termination of the City Manager.


Proposition U compromises our safety. This proposition wants to flood


our streets with untrained officers, against the advice of our own Police Chief Eddie García, who says this rapid expansion isn't "responsible."


